troi of Mormon women or use Mormon men to fill their own pursee, wilfully and maliciously lied to Buchanan until they made him believe that the Mormons were in rebellion against the government. There was no rebellion and that fact was Brigham Young's excuse for keeping the approaching army out of the Territory until the President should send men to see what the real situation was. It took them about two days to see that the Mormons had been clearly in the right, and when the army came into the valley, as it did a few weeks later, it came on terms proposed by Brigham and accepted hy Buchanan's special ambassadors.

Had the Mormons been in rebellion nothing of the kind could have occurred, because one of Mr. Buchanau's commissioners was so prejudiced against the Mormons that he expressed himself to the effect that he would like to see them put to the sword, and yet they were so clearly right that he had to consent to giving them their own terms in an honorable peace.

Hollister, alluding to the coming of the California volunteers in 1862, says "government at Washington thought best to station troops here." He conveys the idea that the troops were stationed here because there was danger of a Morman uprising against the government. The intimation has no basis in fact. If I were to say that governmenteentthe California volunteers here because it was afraid to trust them at the front, so full of the spirit of rebellion was California, I would, in all probability, be nearer the truth than Hollister is in his insinvation.

In 1862 the Mormons were just beginning to recover from the terrible ecourge that had been upon them from the summer of 1854—first grasshoppers, and then what was worse than grass hoppers, the malice of lying bigots and adventurers who succeeded in getting an army sent out against them. One of the best Federal officers ever sent to Utah was Governor Cummiug, and the Mormon Utah Militia kept him snowed in at Camp Scott living on mule meat without salt for months. He no sconer saw the Mormon people and the real condition of affairs than he sent word to the commander of that army that there was no rebellion. Hollister is now as he has been for twenty years an nureliable writer on all matters touching the Mormon people.

Again, Hollister is withholding something when he gives the origin of the church that laid the cornerstone on the occassion named above. 'The "Young Men's Literary Association" was a company of infidels. Independence Hall did not, as a matter of fact, belong to any church in the outset.
