EASTERN DISPATCHES.

NEW YORK, 15.—A very pleasant

WASHINGTON.—Bentwell has ad-

ressed the following letter to the third

and fourth of the Treasury.

"You are requested to suspend action

upon the claims for stores and supplies

furnished ostensibly for the use of the

army, in all cases where the required

returns have not been made by the re-

sponding officer. This course is made

necessary by the fact that ex-officers of

the army have, in some instances, given

their official certificates and receipts for

stores and other supplies, during their

years before the time they were actu-

ally made, in order to bring them

within the scope of their official author-

ity, thus leaving an open door for col-

lection and fraud in the absence of an

important guard as official returns."

There was an interview to-day in the

interior department between General

Walker, Commissioner of Indian Affairs,

and a large party of Indians, rep-

resenting the Kiowa, Comanche, Ap-

aches and other wild tribes in the

States Senate for six years, from the

4th of March next, by a vote of 211 to

171. The Democrats voted for Waldo

Bingham.

COLUMBUS, O.—The Masons in Grand

Lodge of Ohio assembled here to-day,

with a very large attendance, and after

being opened in the Master Mason de-

gree, addresses were made by Grand

Master Newcomb and Deputy G. M.

Batten.

WESTERN DISPATCHES.

SAN FRANCISCO, 15.—A severe fight

was made yesterday among the stock-

holders in the Eureka M. Co., to change

the management, but at a late hour the

stockholders in triumph for the old

trustees. About four-fifths of the stock

was represented.

A meeting of Mexican claimants,

last night, adopted a memorial to the

President of the United States, asking

that energetic measures may be adopted

to protect the interests of American

citizens in Mexico.

SAN FRANCISCO, 15.—In May the as-

sessments on mining stocks amounted

of front in the intrinsic value of stocks

is enough to explain the reason for the

dueness in the mining shares market.

In the matter of the Lums & Co.

bankruptcy case, Judge Hoffman to-

day gave a decision which divides the

assets among the creditors equally, out-

side of Thompson's claim.

Judge Dwinelle sentenced

Wm. Donovan to be hanged. He killed

Minchell, in Solano Co., three years

ago. He was tried three times and on

the last trial in this city was convicted

of murder and sentenced accordingly.

CASTROVILLE, Cal.—This morning a

fatal affray occurred between Sam

Rutherford and Ed. Wilson. Several

shots were fired, Wilson was killed. The

head sheriff arrived at the scene

Wilson fell and arrested Rutherford,

but while taking him away he fell to

the ground, seriously wounded. Rutherford

is badly hurt, but is not expected to

die. Watsonville, Cal., 15.—Reynolds,

one of the prisoners that escaped from

Monterey jail, a few days ago, was

captured this p.m. near this place.
