General Logan's Speech.

Toleno, 11.—Gen Ino. A. Logan was present tals afternoon on the ground of the State Fair Association, and made a speech to an audience number about half an hour upon the commercial, manufacturing and agricultural interests of Ohlo, and their wonderful

growth.

Gen. Logan spoke at League Park tonight. He began by briefly reviewing the history of the republican and democratic parties from 1840 down to the present time, claiming the only motument erected by the democratic party in this country had been its course in relation to free trade. "I will not say," said he, "that they are acting as the paid agents of the British Government, but I do say, misguided though they are, they performed the same service for the British Government which they, had they the power in this counvice for the British Government which they, had they the power in this country, that the Lords of England would have performed if they had seats in the Congress of the United States." [Applause.] As another democratic monument the speaker cited slavery and its attendants, including the war. In reply to a portion of Governor Hendrick's speech last night. Gen. Logan said: "Mr. Hendricks last evening, if he is correctly reported in the newspapers, stated to his audience that the Republican party had been derelict in its duty towards foreigners in this land, who had been permitted to suffer because of the failure on the part of the Republican party to perform its duty. Now, I am sorry Mr. Hendricks made that statement, for 40 years ago as is well known by every reader of political history in this country and I speak of that time because of the faet that the democratic party controlled the government nearly all that time, a foreign government led by England, announced the doctrine that once a citizen always a citizen. That doctrine of self ex-patio was not a correct one: that a citizen did not correct one; that a citizen did not thereby sever his allegiance from the mother country and should they re-turn there they would still have con-trol of him as a citizen of their own government. While the Democratic government. While the Democratic party stood in control of this county for the length of time I have mentioned, let my friend Hendricks point out one single statute that was enacted by the democratic party declaring that a citizen of the United States should be protected

whether he was native or foreign born, when he passed back to his native country. Now, I tell you to-night, that it was left for the republican party in 1868, after the war had concluded, to pass a law that a citizen of this country, foreign born, should be pro-tected on his own mother soil in person and property, the same as if he were a native born citizen; and never was that doctrine enunciated in a sin-rie statue by the democratic party, nor was it ever done until the said republican party announced that doctrine, and it was because of the fact that per-sons of foreign birth who had taken the oath of allegiance to this country returned to their former homes, and were impressed to army service. Now, then, why should Governor Hendricks say here last night that the republican say here last night that the republican party had failed to perform its duty towards foreign born citizens? I am sorry to hear a man who is running for the office he is, make such a statement, when he must know he can be contradicted by the very statutes in the books, and the dates given, and that the republican party performed the act that he claimed never was performed by them. And let me return again ed by them. And let me return again to the fact, passing back to 1800 and 1801, and speaking of the democratic party failing to support the republican party in the proper way in sustaining the armies of the nation, I would like to call your attention to the fact that when the proclamation was issued sup-pressing slavery in this country, the democratic party everywhere oppose

it, in Congress and out of Congress, and no act has ever been passed yet in the form of human freedom and in the form of liberty, that God intended man should enjoy, by the democratic party in or out of Congress."]Ap-Logan discussed at some length the tariff plank in the democratic plat-form, lasisting it meant free trade, and said: "When the southern States decided and established their confed-eracy in the Confederate Constitution,

eracy in the Confederate Constitution, Sec. 8, it was provided that no tariff should be levied to foster the industries, and no bounty should be paid. In other words, they declared in favor of free trade, and the moment they did that, they received the sympathy of England, and not only sympathy, but the English furnished them with munitions of war, arms and ships, to destroy this country. Why Because the eleven seceding States would have been open to hercommerce Because the eleven seceding States would have been open to her commerce and her manufactures, and it was for that reason, in my judgment, that England lent her support to the great rebellion against this country. The dead ocratic platform of 1880 demanded tariff for revenue only, the Confederate constitution 'tariff for the expenses of the government only,' no tariff for the fostering of industries, and the platform of 1884 demands a tariff sufficient only for the economical administration of the Government. They mean the same thing, the only difference being that one was a constitution and the other a platform."

In contradistinction of this, General Logan then proceeded to discuss the position of the republican party on the

position of the republican party on the tariff question, and to the discussion of this question a greater part of his speech was devoted. He closed his speech with a brief discussion of the political situation at present in the

CLOSING SCENES IN TRE LIFE OF TWO GREAT MEN.

The last scene of all in fiction and biography is generally the most affect-ing and often the most characteristic. One might make a curious collection of extracts to show how frequently those who are just crossing the river recur, at the moment of unconscious-ness, to striking events in former years, or to occupations which have taken a strong hold of the sufferer when in active life. The last words of Napoleon were remarkable for this, and we have lately been struck by the account of the death of that great Magistrate, Chief Justice Parsons, of Massechusetts in the ways of the second of the death of the great Magistrate, Chief Justice Parsons, of Massechusetts in the ways of the second of the sachusetts, in the memoir by his son, the late Professor Parsons, of the Har-vard Law School: "His thoughts when he could no longer control them, went back to his duties and his business, he could no longer control them, went back to his duties and his business, and responded unconsciously to his condition, as death drew near to close his earthly career. When he spoke, it was as a Judge, giving answers, directions etc. At last, after a suspense of all speech so long that we thought we should never hear his voice again, he suddenly revived, and, with perfect distinctness, spoke for the last time on earth, that formula which he had used hundreds of times: "Gentlemen of the jury, the case is closed, and in your hands. You will please retire and agree upon your verdrict."

Almost the same thing is said in the biography of Lord Chief Justice Tenterton. We quote from his life by Lord Campbell: "An access of fever supervening, he was put to bed, from which he never rose. He became delirious and talked incoherently. Afterwards he seemed to recover his composure, and, raising his head from the pillow, was heard to say, in a slow and solemn tone, as when he used to conclude his summing up in cases of great importance: 'And now, gentlemen of the jury, you will consider of your verdict.' These were his last words. When he had uttered them his head sunk down, and in a few minutes he expired without a groan."

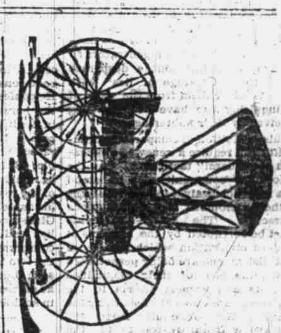
