ALDRICH BILL AMENDMENTS.

Senator Informs Republican Leaders They Will be Satisfactory to Majority of Senate.

Washington, April 13 .- That the Al drich currency bill as passed by the senate will not be concurred in by the house is the conviction of many Republican members of the lower cham-Indeed, that any currency bill will be passed at this session is not positively assured, but if plans which were matured today by the Republican leaders in the house are approved by a Republican caucus to be held next week, the Aldrich bill in an amended form will become a law.

The Republican leaders have ascertained in a purely informal way that with certain amendments the Aldrich bill can get enough supporters in the house to assure its passage and Senator Aldrich, it is stated, has informed them that the amendments they have in mind will be satisfactory to the majority in the senate, To the caucus will be submitted a new currency bill jority in the senate. To the caucus will be submitted a new currency bill drafted by the Republican leaders in the house and introduced today by Representative Vreeland of New York, which embodies so much of the Aldrich bill as they feel confident of, and in which is incorporated the amendments agreed upon. As it is generally recognized that sentiment in the house in favor of such a radical reform in the national money system as a change from a bond-secured to an asset currency is not strong enough to uphold rency is not strong enough to uphold the Fowler bill, the question in the caucus will be simply whether there shall be an amended Aldrich bill or no financial bill at all.

CURRENCY COMMISSION.

If by the time the caucus meets the of Senator Aldrich to pass a currency-commission bill, such a measure will be agreed on by the caucus and passed by the house. It is believed that it will go through the senate.

In support of the no-legislation idea, it is suggested that such a course would leave the Republican party without encumbrance at the Chicago convention and enable the free shaping there of a financial plank.

In the bill introduced today by Mr. Vreeland, the Aldrich bill, so far as it appertains to the issuing of currency on municipal bonds, is left unchanged. The section of the Aldrich bill which changes the present law of reserves is stricken out entirely. This is the section which has met with the most objections of the banks both in the country and in the reserve cities. The last clause in the Aldrich bill, commonly called the La Fellette amendment, is stricken out. These sections were eliminated on the theory that neither one was necessary to a purely emergency bill—on the agreement that the bill should be held as closely is possible to its purpose of providing simply for an emergency currency; that it was not desirable at this time to go mio a revision of the banking and currency laws, but that the work should be, and would be, taken up by a commission to be created before Congress adjourns.

VREELAND SECTION ADDED.

In the Vreeland bill a section is added to the Aldrich bill to meet the objection of the western and southern banks that they own no bonds such as are required for security under the Aldrich bill that they do not only all able drich bill; that they do not feel able to divert their money to the purchase of such bonds, and that all of their funds are required in the needs of their business. Such an association shall have offices and a board of directors selected from the representatives of the selected from the representatives of the banks composing the group and shall be organized and governed according to rules to be prescribed by the secretary of the treasury. Any bank belonging to such an association may deposit and assign to the association in trust such securities, including commercial paper, as may be satisfactory to the officers of the association.—The association may thereupon make applicaofficers of the association. The asso-ciation may thereupon make applica-tion to the comptroller of the currency in behalf of the depositing bank for authority to issue additional bank notes an amount not exceeding 75 per cent the cost value of the securities so posited.

The association is made a corporation for the purpose of the act only. Upon failure of any bank to retire its circulating notes, the association can sell at public sale the securities deposited. If there should be a deficiency after the sale, that deficiency is made a first lien upon the assets of the bank issuing the notes. If there should still be a deficiency the assets of all the banks belonging to the association are made liable in the payment of the notes. All of the other provisions of the Addrich bill are made applicable so far as they apply to this section. The methods of existing clearing-house associations are used so far as posible in framing the provisions of the Vreeland bill. It has not been thought best to disable existing clearing-house associations nor to exercise government control over them. The association is made a corporation

RICHARD HALL ACQUITTED OF CHARGE OF STEALING

Seattle, Wash., April 13 .-- A special to the Times from Dawson, Y. T. says that Richard Hail has been acquitted of the charge of stealing gold dust to the amount of \$40,000 from a Yukon river steamboat last summer, which was consigned to Seattle by persons in Fairbanks, Alaska. The jury which deliberated on what has been pronounced the most famous criminal case in the Yukon territory reached its conclusion after two hours.

Hall was not placed on the stand, and no defense was made for him other than to introduce witnesses to

other than to introduce witnesses to prove his good character.

Crown Prosecutor Pattullo required two hours for his argument, and was greatly surprised by the verdict. The defense was conducted by C. W. C. Tabor. In charging the jury, Justice Dugas emphasized the point that it was extremely doubtful if Hail was with the conductments. guilty of any of the three indictments

against him.

House Committee Agrees to Recommend Passage of the Bill Drawn By Sub-Committee.

Washington, April 13.-The hose committee on mines and mining to-dya agreed to recommend the passage of a bill drawn by a sub-committee for the establishment of a bureau of mines in the department of the inte-rior. By the terms of this bill it shall be the province and duty of the new bureau to "foster, promote and devel-op the mining industries of the United States; to make diligent investigation of the methods of mining, the safety of the miners, the possible improvement of conditions under which mining oper-ations are carried on, the treatment of ores, the use of explosives and electrimmittee on mines and mining toores, the use of explosives and electri ores, the use of explosives and electricity, the prevention of accidents, the values of mineral products and the markets for the same, and of other matters pertinent to said industries, and from time to time make such public reports to the secretary of the interior may direct of the work, investigation and information, obtained with

gation and information obtained, with the recommendation of such bureau."

Provision is made for the government of the bureau, under the secretary of the interior, by a commissioner to be appointed by the president at an an-nual salary of \$6,000.

INJUNCTIONS.

Senate Judiciary Committee Reports Bill Regulating Them.

Washington, April 13.—Through Senator Overman, the senate committee on judiciary today favorably reported a bill regulating the practise of granting injunctions by United States courts restraining the enforcement of state statutes. The bill provides that no circuit or district court shall issue such temporary injunctions on the ground of unconstitutionality until testimony shall have beed taken by three judges, at least two of whom shall be circuit judges. It requires five days, notice of of such bonds, and that all of their funds are required in the needs of their business. The bill also provides for a direct appeal of such cases to the supreme court of the United States, and gives them precedence there. WOOD PULP CASES.

Attorney-General Bonaparte Says Investigation is in Progress.

Washington, April 13 .- The attorney Washington, April 13.—The attorney-general today sent to Speaker Cannon a letter in reply to the house resolution asking what steps have been taken by the government to investigate the alleged combination of wood pulp or print paper manufacturers. The attorney-general says an investigation is in progress, but no evidence has yet been obtained to justify legal proceedings.

He says that when the investigation and the report thereon is completed he will submit them without delay if he can do so without affecting the interests of justice, but that if the investigation should lead to civil or criminal tracecdings it may continue expedient roccedings it may continue expedient to temporarily withhold from the puo-lic the evidence and information.

PUT POISON IN FLOUR.

Francisco Nicolazzo Says He Did it at Suggestion of Victim's Mother.

Chicago, April 13 .- Francisco Nicolazzo today declared that the death of Mary Renda, an 8-year-old girl who died some days ago under suspicious circumstances, was caused by polson which he had placed in the flour at the suggestion of the girl's mother. Nico-lazzo was a friend of the Renda family and declared today that the woman asked him to buy the poison, and, after he had done so, requested him to mix it with the flour. When his confession was read to the woman in the presence of Nicolazzo she made a vicious attack upon him and it required the full strength of two policemen to drag her strength of two policemen to drag her

strength of two policemen to drag her away.

Mrs. Renda charged Nicolazzo with the crime, and declared that she believed it was his intention to poleon herself and her husband, for the purpose of securing a sum of money that they had saved, and a portion of which she carried about with her. Nicolazzo, according to Mrs. Renda, was not at the breakfast table the morning the poisoned bread was eaten, but returned later to learn what the effect of the poison had been.

Nicolazzo, by his own confession, has been in trouble with the police at Rumford, Me., where he was arrested for the murder of Francisco Vallerio, but was acquitted.
