

BOGUS OFFICER ARRESTED AT LAST

W. H. Parent Captured at Denver
And Will be Brought to
Salt Lake.

FIGURED IN M'WHIRTER CASE.

Second Principal in the Famous \$100,000 Robbery Now in Hands
Of the Law.

Denver, Feb. 15.—W. H. Parent, one of five men alleged to have abducted Alexander and William McWhirter of Salt Lake City out of approximately \$100,000 in cash, was arrested here this evening by Deputy Sheriff Leonard Delue. The arrest was the result of a peculiar incident. Sheriff C. F. Emery of Salt Lake City and Joseph C. Starr, chief of his criminal department, came to Denver on business wholly foreign to the McWhirter case. Casually they related the story of the memorable game to Delue.

"I know that fellow," said Delue, when Parent was described, "and I will get him."

Inside of an hour Delue had Parent and the latter had been identified. Sheriff Emery at once wired Gov. Cutler to rush requisition papers. Parent will make a fight. He admits his identity. With Parent's arrest, three of the quintet are at large now. They are the two O'Briens, and Bell, also known as Sinclair.

Parent is in the county jail, where he will be held until requisition papers arrive. He is about 26 years of age and so far as is known has been employed since he arrived here.

Sheriff Emery said tonight that there could be no question that Parent is the man wanted. It is not believed that the other fugitives are in Denver.

This is the second of the men connected with the McWhirter robbery to be apprehended and placed under arrest. Jim Donaldson being the other one. The two O'Brien brothers and the man who was called the "millionaire" Bell have so far eluded the millions of the law. That all will finally be called to account for the perpetration of the boldest robbery in the history of Salt Lake, is confidently expected by Sheriff Emery and his deputies.

Parent is the man who impersonated an officer and who, assuming the name of Davis, took from Alexander McWhirter upwards of \$8,000, after others of the hold-up game had unheeded the Scotchman out of more than \$2,000. The bogus officer, who had displayed a star, upon entering the room, placed all present under arrest, but so worked the game that the two McWhirters were the only ones that did not escape. The money taken was to be returned at the police station, and a receipt therefor was given, but the spoil was taken elsewhere, and through the alleged connivance of certain police officers, the Scotchman got but \$1,000 of their money.

When the man just captured is brought to Salt Lake, which is sure to be the case, startling developments are likely to be made. Donaldson is to have his trial on March 27 before Judge G. G. Armstrong.

AN IDAHO TRAGEDY.

Rancher and His Wife Found Dead by
Their Children.

Emmett, Ida., Feb. 15.—News reached here early this evening of a terrible tragedy at the home of A. Kuckku, a rancher living a mile and a half from the town. Mr. Kuckku, and wife were found by their two children, a boy aged 19, and a girl aged 12, lying dead upon the kitchen floor in a pool of blood, late in the afternoon when the children returned home from school. The bodies were seen by the children through the kitchen window, and they rushed into the house and they hastened at once to town and summoned Dr. Green. MILLIONAIRE MCKENZIE.

Sentenced to Five Months' Imprisonment for Refusing to Pay Alimony.

Chicago, Feb. 15.—David Mackenzie, a mine owner of Boise, Ida., and said to be a millionaire, was today sentenced to five months in the county jail for failure to pay alimony to his divorced wife in accordance with a decree issued by a local court a year ago. Enforcement of the sentence was suspended to permit Mackenzie to file a bond on an appeal.

KANSAS SENATE.

Bars Star's Reporters Because of Adverse Comments.

Topeka, Kan., Feb. 15.—The Kansas senate today by a vote of 24 to 13, adopted a resolution barring representatives of the Kansas City Star from the floor or galleries of the senate. The action was taken because the Star printed articles commenting upon the alleged pro-railroad tendencies of the senate.

NO "JIM CROW" CARS.

Guthrie, Ok., Feb. 15.—The constitutional convention today postponed indefinitely action upon the separate coach proposition, and passed a motion to cause a two days' notice to be given before it can be taken from the calendar. It is said that this action means the defeat of the "Jim Crow" law.

The committee on private corporations today reported favorably on a proposition to prevent the piping of natural gas out of the state.

MILITARY POST IN CUBA.

Washington, Feb. 15.—The general staff has submitted to the president tentative plans for the erection of a military post at Guantanamo, Cuba. The navy has a considerable station at that point, but having no artillery force for shore defense, it is necessary for the proper defense of the place to provide a military post garrisoned by one or two companies of coast artillery and equipped with ordnance sufficient to insure the safety of the naval base.

STARTLING TESTIMONY IN BROWNSVILLE HEARING.

Washington, Feb. 15.—Startling testimony concerning alleged plans to massacre colored soldiers at Brownsville, Tex., by men from the town firing over the barracks to stampede the soldiers and challenge them to come out of the barracks, was given by negro ex-soldiers today at the investigation before the senate committee on military affairs.

William Mapp, a member of company C, was asked if he had ever heard any discussion of the shooting which caused him to suspect any persons of complicity. He replied that at breakfast in the morning following the shooting he had heard William Voischelle, a corporal in company C, and a white man who had been in charge of the corral prior to the arrival of a battalion of the Twenty-fifth Infantry, discussing the case. According to Mapp's story, Voischelle said: "Well, it is a good thing it happened as it did. I was out in town last night, and the crowd came in front of me. The plan was to catch a lot of you fellows in Allison's saloon and massacre you."

Mapp said that on the night of the shooting he had been awakened by the firing and had gone to the window of his quarters and from there he saw several gun flashes, and the shots seemed directed over the barracks. A man with a deep voice, he said, shouted: "Come back, you niggers, and make it applicable to the troops. Mapp said he got his back from the rack that was broken open, and was one of the first to fall in.

Thomas Jefferson, room orderly in company C barracks, said he saw the flashes from the guns and thought the garrison was under attack. He said he saw the company B quarters and that the shots were apparently over the barracks. He said he heard a man shout and then yell: "Come out, you black—"

There was great excitement in the barracks and when the cut racks were broken open some of the rifles fell to the floor. There was no light, and the men could not get their own rifles.

BRIDGE COLLAPSED.

Five Workmen Injured, Two Probably
Fatally.

Portland, Feb. 15.—Five workmen were injured, two perhaps fatally by the collapse of a bridge on which they were working just before noon today. The men were erecting a "pony" bent to carry a derrick when the bridge, which was broken open when the derrick fell to the deck of the bridge, which broke, precipitating the men into a quick 40 feet below. The more seriously injured were H. B. Hardin and E. Thompson.

GREAT SNOW AT VALDEZ.

Seattle, Wash., Feb. 15.—Lieut. Col. W. A. Glassford, in charge of the United States signal corps, received word here today from Valdez, Alaska, that a terrific storm was raging in that vicinity. At Valdez the snow is seven feet deep and the wind is blowing a gale.

At the summit of the trail between Valdez and Fairbanks the snow is 10 feet deep and all traffic between the two towns is entirely stopped.

The operator at Valdez also states that the wires between Valdez and Fairbanks are down near Thompson's Pass. The weather is too cold for the linemen to venture out to repair the line.

RAILWAY ACCIDENTS.

Julius Kruttschnitt Would Publish
Names of Those Responsible.

New Orleans, La., Feb. 15.—As a preventive for railroad accidents complete publicity is suggested by Julius Kruttschnitt, director of the Harriman lines and vice president of the Southern Pacific. "The persons responsible for accidents whether officers or laborers," said he, "should be known to the public in order that they may be able to feel the weight of popular displeasure."

COLORADO IS REVENGED.

Utah Team Defeated in Oratorical
Contest With Colorado University.

A special dispatch from Boulder, Colo., announces that the Utah debating team went down to defeat at the hands of the Colorado orators yesterday. The contest was an exciting one, the tension of feeling running high between the partisans for each team. Colorado remembered her defeat by Utah a year ago, and was determined that this time should record a victory for her sons. Utah was represented by good men, but by unanimous decision of the judges, Colorado bore off the palm.

The question for debate was: "Resolved, that the best solution of the Cuban problem is annexation to the United States." The Utah boys drew the negative, and although feeling in common with every other American that the affirmative of the question is right, they nevertheless put up a good argument, and gave the Coloradans a good run for their money. The Utah university team comprised Goddard, who was one of the team defeating Colorado last year; Bramwell and Brown. The Colorado team was represented by Remington and Nafe, both of whom were on the losing team last year, and Kelso, making his first appearance. The exercises were presided over by Secy. of State O'Connor, and the judges were Prof. W. R. Thomas of the Colorado Agricultural college; former Congressmen Sharfrott, and E. K. Whitehead of Denver.

Just before stepping upon the stage, the Utah boys were handed the following message from the University students: "Do it now Utah; we are with you."

Each Utah man will be presented with a gold watch-fob for representing the University in the debate. Upon the fobs will be engraved the date of the debate and the team with which the contest took place.


