THE HILL CASE.

He goes to the "Pen" - A Soft Filter by Mrs. Hill.

Contrary to general expectation Oscar E. Hill, the alleged weaker of the Commercial National bank, was unable to give the required sum of \$10,000 when it came to the scratch yesterday, and therefore had to pay the necessary amount in cash, which he has no place where he will be liable to remain until his case is called up in the district court, unless the bank can be raised before that time. He is said to have arranged with Captain Captain Davis and gave himself up in default of the required sum, and thus exonerated his former business, some of whom are very much relieved and returned to again oblige themselves for Hill's services.

There was somewhat of a surprise in Hill and his attorney, Captain Smith, as they were confident that a bond could be given without trouble.

Mrs. Hill commenced suit against the bank for recovery of the amount of her home on Jefferson Avenue, which she transferred to him believing that the amount of the shortage, caused by the embezzlement of her husband, was about \$10,000, and that the property owned by him was sufficient to meet the claim. The bank claims that the embezzlement was far greater than \$10,000.

An attorney who has been engaged to represent Hill in his defense, and who is well known in Ogden, has agreed to take the case.
