city sewerage to the place of deposit. The committee therefore asked that the canal be maintained; that a written agreement be entered into between the county, the city and the North Point Consolidated Irrigation company, declaring the ownership of each to be equal in that portion of the canal above the present headgates of the North Point canal which are fixed in the intersection of Third South street, westward to an intersection with the last named canal, and obligating each to bear an equal share of the cost of maintaining the canal above this point. Adopted.

# THE OLD SILK FACTORY.

The committee on public grounds submitted the following on the petition of S. I. Clawson and others refering to the old silk factory: After carefully looking over the ground, and consid-ering the recommendation of the chief of the fire department in connection therewith, we find that there has been no petition presented to this council asking for further fire protecthis tion than they now have, and to fit it up for the purpese of a hose house would cost the city \$250 or more. We further find one corner eight feet on the sidewalk, the whole on a public park, stand contrary and on an angle with streets abutting and the majority of the citizens opposed to using it for is the citizens opposed to using it for any purpose. Having an offer from a responsible party to remove it, and level the ground up without cost to the city, we would recommend that the old silk factory be abolished forthwith. Adopted.

The city engineer reported that the use of crematories for the disposal of garbage could be used only on the payment of royalties, and he recom-mended that bids be solicited from the different companies owning patents in the same. The cost of a crematory would be about \$11,000. Adopted.
