

# JUDGE POWERS IS HOME AGAIN

Tells the Deseret News He Will  
Run for Congress if He is  
Sure of Defeat.

HE DIDN'T GO TO NEW YORK.

Thinks That Bryan Got Along Without  
Him Last Night—How He Dis-  
covered Col. Wall Asleep.

For many days the impression has been current in Utah that Hon. O. W. Powers, Democrat, and prominent citizen, was down at New York listening to what the wild waves were saying in their joy at bringing William J. Bryan across the pond.

The Bryan dinner was held last night and the hosts that were there counted Orlando W. among them. In the local figuring, but all that time Mr. Powers was sitting peacefully at his Linger-longer home on the east bench. He arrived in Salt Lake yesterday afternoon, and when seen by a "News" reporter at his office this morning, Mr. Powers was looking much refreshed and for all the world like a man just back from the woods after a vacation.

"How's Mr. Bryan?" was suggested. "Didn't you go to New York to welcome the great commoner back to his native shores?"

"Bryan, Bryan," said Mr. Powers thoughtfully, "well I guess they didn't miss me much down at New York. Fact is I didn't know a thing about being wanted down there. I got to Omaha on my way home. Then I picked up a Salt Lake paper at a depot news stand, and found that Senator Bamberger had named me a delegate, to represent him at the reception."

"No, it wasn't the fault of anyone but myself I was not notified. You see I was pretty well out of the reach of telegrams and the mail service as well, for almost all the time I have been away I have been on the water of the great lakes, with Mrs. Powers and our youngsters. My trip was just a vacation, and had no business or political purposes."

When asked as to the extent of his eastern trip Judge Powers said that he was a humble convert of Fisher Harris to the doctrine of "See America First," and had been out doing just that sort of thing. "There's nothing in Europe to compare with the lake country," he said. "Europe oughtn't to be mentioned in the same paragraph with it. The thousand islands are a dream, that's all, and every American should see them and know those lakes before he can know his country. And Utah people, why I struck them everywhere. I do believe Utah people travel more than any other people on earth. They go away up into Canada and over to Europe without thinking it much of a trip."

"Who do you think I met in Niagara city? Walking along the street I heard snoring, and there sitting in front of a hotel sound asleep in a chair was our good friend, Col. Wall. I just pinched him on the leg and woke him up to pass the time of day. Col. T. G. Webster I also met up in the lake country, and in fact there were Utah people everywhere I went, and where ordinary tourists couldn't be found there were missionaries. I met two of them from Tooele, and they seemed very much interested in their work."

When informed that his party was looking to him to take the congressional nomination this fall, Judge Powers laughingly replied that he would accept it if he was sure to be defeated, but chances for Democratic victory were so good this fall that he hardly saw how he could accept. However, it was apparent that he will not jump out of the saddle if he is forced into it, and will be found making the same spry finish that has characterized his campaign work in the past.

State Chairman Jas. T. Hammond of the Republican party was busy today with Republican politics in so far as Sanpete county is affected by it. At his office in the McCormick block, Chairman Hammond received a delegation of Sanpete county workers, consisting of Sven O. Nielsen of Fairview, and Fred C. Jensen of Mt. Pleasant. The men brought up much political news for Mr. Hammond, and in an interview expressed themselves frankly on the situation in that county.

For the local offices in Sanpete county, the disposition is to run the present incumbents again on the Republican ticket, where they have had only one term. For the senatorship to fill the place now occupied by Senator Larsen of Mantu, there are numerous aspirants preparing to make the run for the nomination. Larsen will probably be a candidate for re-election. L. R. Anderson, mayor of Mantu, will be out for the place, as will also Henry Kearns of Gunnison.

In Millard county, Senator Callister holds over, so there is no senatorial contest down there. In the county ticket the Republicans expect to nominate present incumbents in the main, except in cases where they have had two terms.

The Democratic city and county committee met last night and adjourned again without finishing the business of electing a successor to Herman B. Martineau, promoted, and Will G. Farrell, his secretary. The reason given out was that county members of the committee were not present in sufficient number, so written notices having been sent them to attend. Next Wednesday night the postponed meeting will be held at which the new chairman and secretary will be named. The meeting was held in the office of State Chairman Martineau, and remained in session from 8 o'clock until nearly midnight.

## CLOUGH BABY DEAD.

Infant Died Today After an Illness of Six Months.

The many friends of Mr. and Mrs. W. H. Clough of 1621 West Second South street, will be pained to learn of the death of their infant daughter, Margaret, which occurred this afternoon at 12:15 o'clock. For more than six months the child has been ill with a complication of diseases, among which was typhoid fever, and its death was caused by intestinal trouble. During her illness everything possible was done for her by the parents who watched over her day and night. During the very warm weather they took her to the canyon with the hope of bettering her condition. However, she did not seem to improve so was brought back to the city about three weeks ago. It was thought for a week past that she was improving, but this morning she became worse and sank rapidly until the end came. She was 14 months and 22 days old. The arrangements for the funeral have not yet been made.

## ROSEWATER, EDITOR OMAHA BEE, DEAD

Omaha, Aug. 31.—Edward Rosewater, proprietor and editor of the Omaha Bee, and prominently identified with the political, financial and business affairs of Omaha, and the state of Nebraska for 46 years, was found dead in district court room No. 6, on the third floor of the Bee building, early today. He had evidently died of heart failure.

Mr. Rosewater went to Waterloo, Neb., Thursday afternoon, where he delivered an address to the old Soldiers of Nebraska, who were holding a picnic at the city about three weeks ago. It was his return trip at 7 p. m. He is known to have been in his office during the evening, but was not seen by members of his family after returning from Waterloo.

It was a habit of Mr. Rosewater to go to different parts of the building whenever his pleasure so induced, and it is presumed he stepped into the large court room and sat down for a minute's repose and fell asleep.

When Judge Troup, who presides over court No. 6, arrived at the court room this morning he was surprised to find the lifeless body of Mr. Rosewater on a bench. He was sitting at the end of the bench, reclining easily against a radiator. He had reclined his head on his extended arm, across an arm at the end of the bench. In his right hand he held a handkerchief, having evidently felt warm and used it to wipe the perspiration from his face.

Mrs. Rosewater left a light burning at the family home, which is directly in the rear of the Bee building, anticipating that her husband would be home during the evening. When he did not appear Mrs. Rosewater notified Chief of Police Donohue that her husband had not returned home. Although it was known that he had been at his office during the evening, nothing was done in the way of search, however, as it was not uncommon for Edward to be detained late at the newspaper office.
