MUNICIPAL MATTERS.

Business Transacted by the Council Last Night.

BICYCLE OBSTACLES DISCUSSED.

CITY ATTORNEY RECOMMENDATIONS.

Upon the recommendation of the city attorney, provision was made for the payment of witnesses in the case of Guy C. Boyce against the city.

The city attorney recommended that \$25.00 be paid to the contractor for the work done on the board of public works, which was adopted.

AS TO COMPENSATION.

The petition presented by the inspectors upon the gravity sewer in December last, is the second bill for the same and is for the sum of \$100.00.

Commissioner Cotton and Watson, representing the city on the board of public works, referred the resolution by Commissioner Cotton, instructing the board to cancel all fire insurance carried by the city, reported that the county members had refused to join in the proposed cancellation, and expressed the opinion that such cancellation would be unwise.

THE IRVINE DIVORCE SUIT.

As Arranged by Which a Second Trial Has Been Avoided.

The Irvine divorce suit has been temporarily settled without going to another trial, Chief Justice Merritt having in chambers last evening granted the decree, as per stipulation between the parties. This was done upon a supplemental agreement.
