LOCAL ITEMS.

UTAH AND ROMAN CATHOLICISM.—The Archbishop of Baltimore announces that the Pope has erected nine new Episcopal Sees and four new Apostolical Vicariates, in the United States. Among the latter are Colorado and Utah, forming the Vicariate Apostolic of Colorado, with the Right Rev. J. Proculus Machobouf, Vicar General of Santa Fe, appointed to preside over it.
