Eugene Jenks and Ray Curtis were arraigned before Judge Nye this morning on the charge of grand larceny, to which both pleaded not guilty. The State was represented by Assistant County Attorney Patton, the defendants were represented by Attorney C. W. St. John.

The case for which the defendants were arraigned today consists of their stealing twenty blackberries, of the value of \$1 each, the property of the Cold Water company, during business on Indiana avenue, this city, and occurred on the 30th of last month. The defendants were given a hearing before Justice Wenger, and by him held to the district court on said charge. Both are mere youths in appearance. Little is known of their past career, but Curtis is well known to the police, having been in court a number of times on various charges.

Will Go Over Next Monday.
Today Chief Justice continued the reading of Haydon's testimony in the Morris debent case of May, 1893. Attorney Rhodes announced yesterday afternoon that urgent business required his presence in Ogden tomorrow and he requested a continuance of the hearing until Monday. ILLEGAL TAXES REFUND.

Red Tape to be Blown in Getting Money Back.

Resolved, That the board will allow and hereby order a refund of county school taxes illegally collected within Salt Lake City, Utah, for the year 1900, but only on the following conditions, and no refund will be made until a verified claim is approved by the county auditor and presented to this board. Second, that the refund be made only on such claim as is verified and approved by the board. Third, that such claim is both verified and approved by the board for payment to the county treasurer within ninety days after January 20, 1907.
