

# PENNY'S SLAYERS FACE TRIAL AGAIN

Harpers and Armstrong Woman  
Are Held by Colorado  
Officers.

WERE ONCE DISCHARGED.

Prisoners Were Hunted Down But  
Were Released Because Bodies  
Could Not Be Found.

Denver, Oct. 28.—Charged with having committed murder in a long-ago case, Mrs. Mary Armstrong and Jack Harper were placed under arrest officers connected with the sheriff's office in this city, today, while George Harper was captured at Fort Collins by the marshal of that town on telephonic orders from Sheriff Nisbet.

Eight years ago Mary Penny and her son, George, disappeared in Millard county, Utah. George Harper and Jack Harper were arrested at that time, charged with the killing of an unknown person. They were released because the bodies could not be found.

Last week several mining prospectors discovered two skeletons in the Pecos hills. Miss Emma Pence, daughter of the late Penny, accompanied a brother to the place and there identified one of the skeletons as that of her father. The identification was made through a peculiar pattern of bridge work which Penny had done on his teeth some time before his disappearance.

## LAST SEEN OF PENNY.

Mrs. Armstrong and the Harpers were seen by two shepherders, it is said, in company with the Penny's when the party passed their camp on the evening of Oct. 18, 1899. About a week later the Harpers and the Penny's were seen at the following morning the Harpers and Mrs. Armstrong were seen returning with the Penny outfit. The Penny's were not in sight.

When the bodies were found Sheriff Black of Millard county went to Salt Lake City and from there telephoned to Sheriff Nisbet. This was last Thursday.

Jack Harper was located at Layden, where he was working on a ranch. Mrs. Armstrong was arrested at her home on Center street, Denver. From there it was learned that George Harper, who, according to the Salt Lake dispatches, had died long ago, was working in Fort Lupton.

None of the accused would talk about the case. Sheriff Black wired Sheriff Nisbet that he had secured regulation papers on Gov. Huchel and would leave for Denver this afternoon.

## STORY OF THE CRIME.

Penny's Disappearance Eight Years Ago and Following Incidents.

Dist. Atty. Melville of Millard county and W. P. Payne of Fillmore are in the city to assist in bringing the alleged slayers of the Penny's to this city to face trial. Gov. Huchel will return from Sevier county this afternoon and will then honor the regulations directed to Gov. Huchel for the return of the prisoners now being held in Denver for the Utah officers. Upon the completion of the papers, Sheriff Black of Millard county, with Mr. Payne, will leave for Colorado to bring the prisoners back.

The story of the disappearance of the Penny's has been told many times. The prisoners now under arrest were held for the Penny murder soon after their disappearance became known. They were released, however, because the bodies of the supposedly murdered men could not be found. Joe Burt and Adam Paul, who were arrested by Sheriff Kelly of Millard county.

## SUSPECTS HAD OUTFIT.

Mrs. Mary Penny and her son George Penny left their homes eight years ago to go into the hills in search of unknown prospects. The last they were seen alive was in the company of the three persons now under arrest. The Penny's and the other three passed a sheep camp in Millard county. A few days later the Armstrong woman, Jack Harper and George Harper were seen by the shepherders with the Penny outfit. The Penny's were nowhere in sight. A reward of \$500 was offered by Gov. Wells for the return of the three suspects. Their arrest was made at Mantle shortly after following a man hunt of sensational turn.

## KEPT UP SEARCH.

Year after year the members of the Penny family have kept up a search for father and brother. They employ Indians to aid them in their search. The bones of the two men were found by some of the searchers a few weeks ago and members of the Penny family have identified them by means of some peculiar bridge work that was found in the mouth of the larger skeleton. The Penny's and the other three opened the sensational finding that the bones

were those of Indians. Physicians and members of the family, however, are positive in their identification of the bones as those of white men and of the Penny's.

The bones are now in Kansas and have not been interfered. They will probably be kept above earth until the proceedings against the alleged slayers are ended.

## MILLIONS OF CIGARETTES.

Seized by Collector of Customs and May Be Forfeited.

Norfolk, Va., Oct. 25.—The information by the government for the forfeiture of 8,750,000 cigarettes owned by the British-American Tobacco company, limited, seized by the collector of customs at this port in two lots Oct. 15 and 21 because of alleged violation of the Sherman anti-trust law, was filed in the federal court this afternoon. It charges that the company "was created as an instrumentality for the special purpose of defeating and violating the laws of the United States and carrying into effect the said unlawful contract, agreement, combination and conspiracy with the several American tobacco concerns."

## EDITOR JOHN BARRETT DEAD.

San Francisco, Oct. 28.—John Barrett, news editor of the Examiner, died of apoplexy at 2:30 this afternoon. He was walking on Van Ness avenue when stricken.

A friend to whom he was talking noticed that he seemed about to faint and summoned an automobile. Before it arrived Barrett said: "I guess it's all up," and fell to the sidewalk, dead. He was about 34 years old.

Vallejo, Cal., Oct. 28.—All the hand riveters employed in the work on the transport Sheridan at the Mare Island navy yard have struck, following the refusal of Naval Constructor Holden A. Evans, the head of the department, to grant their following demands: They are given piece work at \$12 and \$25 per 100 rivets.

The situation has been telegraphed to the navy department and it is believed that men will be rushed down from the east. The navy yard officials say that work will be delayed not more than three weeks.

## ARCHDUKE FERDINAND DYING.

Vienna, Oct. 28.—It is reported here from Salzburg, Austria, that Archduke Ferdinand IV., grand duke of Tuscany, is dying. He received the last sacrament today. He is 72 years old, and for some time past has suffered from a nervous malady.

The later years of the archduke have been embittered by the conduct of his two eldest children, the ex-crown prince of Saxony, who escaped from several years as the Countess Montijo, who made her notorious and who recently married Enrico Toselli, an Italian piano player, and the former Duke Leopold, now known as Leopold Wooding, who gave up his position at the Austrian court to marry a Viennese actress and who, after a divorce, was married yesterday in Switzerland to the daughter of a horse dealer.


