number of dollars. He is worthy of contempt, and should be prevented from going at large until symptoms of reformation have appeared.

There is one feature of this fish subject which, when calmly considered, is really surprising. Persons who are fully cognizant of the violations of law which fish depredators commit, who are personally and directly interested in the food supply which this class of offenders are destroying, and who display a commendable public spirit, generally fail to take any practical steps in the direction of vindicating the law. If an intelligent citizen were to see some person engaged in destroying a public bridge, or burning a public building, what would he do? Go at once before a magistrate and make affidavit to what he knew relative to the crime, that the offender might be arrested and punished. A person who unlawfully takes or destroys fish, robs the public of a food supply, is the enemy of society, and should be legally dealt with.

## ALL MANNER OF EVIL FALSELY.

THE perfidy displayed in spreading the most abominable falsehoods about the Latter-day Saints and their religion is truly appalling. As an instance we quote from a late issue of the Portland (Oregon) Telegram. Speaking of the recent investigation before the Third District Court, that journal says:

"The fate of many, who having violated the oaths of the Church, had been subjected to great torture, their throats cut from ear to ear and their intestines torn out, proves the society to be a desperately murderous one."

No man was killed in that company by the name of Green, or of any other name, nor did I ever hear of any rumor of any one being killed in said company, until I saw the statement of Wardell recently in the papers. I am not a Mormon nor have I been for several years. I am not a believer in Mormon theocracy, but do believe it wrong to have any religious sect or body of people assailed by falsehood.

## THE EXPOSURE HURTS THEM.
