Monday, April 24, 1876. RIGHTS OF RESERVATIONS FOR TOWN SITES

A case of some importance, involving this question arose in my State, that of Root v. Shields, and was decided by the Supreme Court of the United States.

The city was incorporated, and these lands included within the corporation in February, 1870.

The act granting to him such right, if any he had, provides that a party of the character therein described may pre-empt any portion of the public lands excepting those which are within the limits of an incorporated city.
