WANTS AN INVESTIGATION

Mrs. Bell of Murray Says Her Son was Unlawfully Sent to Jail.

Statement Also Made that a Saloon Keeper Supplied Minors With

Intoxicants. A married lady named Bell, residing at Murray, called at the county attor-

ney's office about 4 o'clock yesterday. afternoon and made complaint against Justice of the Peace McOmie and Dep-uty Sheriff W. H. Goldman for what she termed unwarranted conduct on the part of those officials. Mrs. Bell said that the other day her boy and some others obtained drink

from a saloon, and while under the in-fluence of the intoxicating beverage fluence of the intoxicating beverage they helped themselves to some candy which was in a delivery wagon outside one of the Murray stores. The Bell boy was arrested to Deputy Goldman, and taken before Justice Mc-Omie, who imposed a fine of \$15. In default of the payment of the fine the lad was locked up in jail, where he was heart from 11 o'clock in the mornlog

Ind was locked up in Jali, where he was kept from 11 o'clock in the morning until 10 o'clock the same night. He would not have been released, his mo-ther said, had it not been for an ac-quaintance of the family, who, hearing of the affair, went and paid the fine, thus securing his liberation. What Mrs. Eell objected to was the sending of her boy to jail without com-municating with her or her husband.






