We had conferred at Punta Arems with Adam Cardenas, former president of Nicaragua and now head of the Con-servative party, and a mutual promise of co-operation has been exchanged. Cardenas was overthrown from the presidency by Zeiaya in 1891, and re-cently he was reperted as having taken the field against his old enemy, heading an expedition that was preparing in Costa Rica for an attack upon Nicara-gua. It also was asserted that the former president had bound himself to support the candidacy of Gen. Es-trada.

to support the candidacy of Gen. Es-trada. Dr. Madriz was met at Chinandega and Leon by almost as great crowds as had gathered at Corinto, and they shouted "Long live the savior of Ni-caragua!" There was, however, a re-markable absence of hostile cries to Zelaya. The people of Leon were wild in their demonstration of friend-liness. Flowers were showered upon Madriz as though he were a hero re-turning from the war. Cannon were fired and skyrockets shot into the air, despite the daylight Conspicuous in the breeze were two American flags. In a speech of welcome, a Leoneso journalist, perched upon the shoulders of friends at the station, mid: "This is no time for a polley of con-ciliation or pardon. It is the time for a policy of purishment for the of-fenders against the public good." In Managua the situation is tense. Zelaya has offored the American con-sul a guard of soldiers for the con-sulate, but this offer has been declined.

I am not the candi-date of Leon, but I am the candidate of the entire republic. My chief con-cern will be to appease the ancient sec-tionalism that has divided certain lo-calities." 
