CITY COUNCIL.

The City Council met in regular session last night. The members present were: Rich, Folland, Hardy, Horn, Karriek, Evans, Beardsley, Moran, Lawson, Simondi—10.

Absent—Loofbourov, Bell, Heles, Wantland, Kelly—5.

In the absence of President Loofbourov Mr. Beardsley was called to the chair.

The Proceedings.

H. F. Taylor and others asked that a fence on Seventh West between

Fifth and Eight South streets be removed. Committee on streets.

Isaac Hunter asked permission to take ice from a pond on Ninth West street. Committee on Jordan canal and irrigation.

W. S. Gibson asked for lease of the city sand pits on north bench. Committee on public grounds.

Jos. I. Lindsay and others protested against the condition of the Jordan River by reason of sewage being dumped into it and demanded relief. Referred to the Mayor.

George Stringfellow and others asked that crossings be placed from Third to Seventh South on State street. Committee on streets.

Charles H. Lewis and others asked for an extension of watermains on Aberdeen street. Committee on waterworks.

The Odd Fellows Building Committee asked the abatement of a nuisance in the shape of a corral on Market street. Sanitary committee.

A. B. Margetta asked an extension of brewery license. Committee on license.

AFTER GALLEAZZI.

D. R. Parry and others represented that Galleazzi was totally unfit for the office of dog tax collector, and asked that he be removed or divested of police authority. Committee on police.

SUNDAY AMUSEMENTS.

The Wonderland Amusement Company asked permission to give performances on Sunday.

Folland—There is already a law on our statute books which provides for the giving of Sunday concerts. Now they must want something besides which this law grants, and I am not in favor of allowing anyone to break the law with impunity. The Christian denominations, which composes the best part of the city's population, have large interests at stake in the city, and their rights would be trampled upon by the granting of this petition. My voice and vote shall go against it.

Simondi made a speech in favor of granting the request.

Hardy said he was opposed to the application, whether other members were in favor of it or not.

Evans—I am not in favor of acting on the petition tonight.

Moran—Well, I am; the question has been hanging fire for a year and it is time to act now and here.

Rich—I would like the attorney to look up the law on the matter.

Judge Hoge—The city attorney can't find it.

Rich—If the granting of the petition can be done without violating the territorial statutes then I am in favor of it; if it cannot then I shall oppose it. There is no use or sense in us bumping up against the chief executive. The matter was then laid on the table until later in the evening.

INVITATION ACCEPTED.

The Mayor sent in a communication inviting the council to join him in a body and attend the installation exercises and banquet to be given to the Masonic grand lodge by the lodges of this city. The invitation was accepted with thanks and the recorder instructed to so notify his honor.

APPROPRIATION BILL VETO.

The Mayor sent in a communication in which he vetoed the appropriation

bill passed by the Council on the 4th inst., because of the item therein in favor of Monnt & Griffin, on payment for street sprinkling. Referred to a special committee.

TO PUT THEM UNDER BONDS.

This also came from his honor the Mayor which was referred to the city attorney.

All officers, especially those handling any of the money of the city should be required to give bonds for the faithful performance of their duties, in a penal sum sufficient to secure the city against any possible loss. I learn that Mr. Glenn, the clerk of the police court, when he was appointed by the City Council, was not required to give any bonds. I therefore recommend the passage of an ordinance requiring all officers who handle any of the city revenues or funds, who have not already done so, to give bonds and that those hereafter appointed, be required to do likewise before entering upon their duties.

Moran—It seems to me that this is a pretty late date to recommend such action. Somebody has made a pretty mess of it. Oh, this is a nice thing to lock the stable door after the horse is stolen. I wonder what our auditor has been doing. It seems to me that the police judge is responsible; he should be held responsible for Glenn's shortage.

ANOTHER EMPLOYE GARNISHEED.

The Mayor reported that a garnishment had been served upon him in the case of C. S. Rigby et al. vs. W. S. Sherman, a policeman, in which a judgment had been rendered against the defendant for \$175.25 and costs, and referred the matter to the Council for such action as they may desire to take. Committee on police.

SEWER EXTENSION DEFEATED.

The city recorder reported that sewer extension No. 14 for the construction of sewers on E street from South Temple to a point on E street midway between Second and Third streets had been published in accordance with the law. He also attached the protest from John Sharp and others representing 825 feet which was sufficient to defeat the intention as advertised.

A JUNKETING TOUR.

The joint city and county building committee recommended that the city engineer and architect be sent to San Francisco to investigate the fire proofing scheme.

Lawson—I move that the communication be filed.

Rich seconded the motion and said that he was opposed to the heads of departments being sent away. If anybody went a special committee from the City Council should be sent to investigate the question. He moved that the matter be referred to the joint city and county building committee with instructions to select a committee from the council and make the trip referred to.

EXTENSION OF WATERMAINS.

The city recorder reported that the notices of completion for the extension of watermains on certain streets, viz., Sixth South, First West, Eighth West, etc., had been published according to law and submitted the matter for final confirmation. Confirmed.

CITY OFFICIALS' REPORTS.

Several reports from heads of departments were read and referred to appropriate committees.
