In 1877 Congress passed an act known as the Edict of Homestead, for the purpose of protecting homesteads in the territories. The act did not extend that its provisions were for Utah only. Among other provisions of the act, it gave the right of ownership of the land to the claimants, who were all clearly expressing whether it applied to Utah or all the territories.
