The needle work from the beginners' grade certainly speaks well for execution, neatness and design, and every piece of clay modeling and raffia work shows the individuality and character of the child.

The color and drawing work of the Second grade was exceptionally fine, as also the charcoal and raffia work from the third grade. The needle work, pencil drawings and conventional designs showed care in outline, mounting and arrangement. The millnery work is very fine

The Sixth grades showed exceptionally fine work in autumn leaf drawing and color work taken from nature, and the needle work, consisting of drawn work, embroidery and fancy pillows, is very commendable. The schoolhouses drawn in pencil are excellent.

The Seventh grade work showed up most wonderfully in their water color, pastel, charcoal, and pencil drawings. Several framed pastel and water color studies are exhibited that are very fine. Great credit is due the teachers of this grade for the efficient work done. The needle work, consisting of Battenberg drawn work, embroidery, sofa pillows and other useful articles, was excellent Special mention should be given to the full-sized quilt made by the Seventh grade pupils at the Parker school. The blocks were cut, pieced and the quilt put together and quilted in two days. The quilting frames were made and set up in the school room by the boys. A most unique five-shelved cabinet was made by the Seventh grade pupils of the Franklin, in which was exhibited
