SALT LAKE'S STATISTICS.

Report for October issued by the Board of Health today.

Following is the report issued by the board of health today showing the vital statistics of Salt Lake City for the month of October, 1895.

The death-rate per thousand was 3.34, an increase of 1.08 over the same month in last year. The deaths numbered 55, compared with 52 in October, 1894, and are classified as follows:

Zymotic, 10; disease, 1; constitutional, 1; nervous, 3; respiratory, 1; respiratory, 2; digestive, 1; unknown, 2.

Of these, there were males 33 included; 27 white and 1 colored; 15 married; 11 widowers; 3 widows; 27 single, and the whose social relations were not known.

Twelve were natives-born citizens, 24 foreigners, 5 born in other parts of the United States, and 2 whose birthplace was not learned.

Three of the deaths occurred in St. Mark's Hospital and 2 in the Hotel Cross.

There were also 7 premature and stillborn infants not registered in the city.

The marriage license for the month numbered 41, an increase of three over the preceding month.

The births numbered 135, 7 of which were colored; 64 were males and 59 females.

During the month 800 pounds of trout were condemned and destroyed, 500 pounds of poultry, 50 of vegetables, 50 of canned goods, and 25 gallons of milk were condemned.

One hundred and thirty-nine lots of cattle, 120 loads of swine, 100 pounds of fat, 32 cases of eggs, 17 chickens, 3 dead cows, 1 calf, 4 sets, 65 pigs and 17 horses were condemned.

Twenty cases of scurvy fever were reported, and also 42 cases of typhoid fever and two cases of dysentery.

Restored to Practice.

Last evening a News reporter called on Dr. J. W. Taylor and from him learned that at a recent meeting of the Board of Medical Examiners of Utah Territory, a resolution was introduced and adopted to the effect that he henceforth be restored to practice and that he may return to the practice of medicine under the name of his former title. This resolution had never been revoked, and that a copy of the resolution was furnished him under the seal of the board by the secretary, which was accordingly done.

Mr. Hough is thoroughly competent to explain the merits of his work, as he has charge of the excellent exhibit made by the committee at the World's Fair in the Liberal Arts building, and

will be pleased to see a very large audience during the day and evening at the free display.

The association is to be congratulated on securing this fine exhibit, which is in great demand among large associations. Friends of the Y. M. C. A. are invited to call and inspect the work.
