TO PROMOTE PROSPERITY.

"DOUBTLESS in the interest of Salt Lake City and to attract investors and investments to Utah, the Tribune this morning prints a leader from which the following is a characteristic extract:

It says: 'The Illustratet American got most of its material from the Tribune.' We wish to say that whatever it got from the Tribune was the absolute truth; truth that can be established by testimony that would convince any jury on earth. We wish to repeat that an Elder of the Mormon Ohurch, assisted by three others, probably all of them kilders, ane of them we bedeve to be a Bishop, tried to kill a Deputy United states Marshal in a dark alley in this city, that when he falled both the NEws and Herald did their best, by the most shameful and palpable falseboods, to incite this people to riot; that when the Marshal sent the deputy marshal to the penitentary the Mormon thug police tried to get him, and that an Apostle of the Ohurch ordered the Ohief of the Police to take the man from custody when he was brought in for examination, that the Ohief of the Police weakened and told the Apostle that was too much of an undertaking, and that if it was tried and failed and there was an investigation, and he was called upon, he would tell the whole facts. The NEWS sneers because we cannot establish this by a proof that all the world can see.

"And, so off. When did this happen?" world can see.

"And so on. When did this happen? Was it yesterday or was it in the dead past? Could anyone not possessing his-torical knowledge of Utah; could any past? Could anyone not possessing historical knowledge of Utah; could any stranger, upon reading the editorial quoted, tell? What is the sense of keeping the old embers of hate aglow, and what is the impression that this and similar incendiary articles, which form the stock in tracked. which form the stock in trade of the Tribune, must make upon the people of the country at large? Would the Chamber of Commerce, the Real Estate and Stock Exchanges; would our merchants and citizens like to have the paper circulated conveying, as it does, the news that treason against the United States and murder of the government officers are rampant here, who knows, for aught the Tribune says to the contrary, whether today or yesterday? Did the Illustrated American essay to do worse?

"And by the way the introductory sen-

tence of the extract concedes boldly and brazenly that the *Illustrated American* secured part of its material villifying Usah in the sanctum of the *Tribune*. Reread it and see.

"As a promoter of prosperity at a time when all our people are bent upon that consummation, the Tribune is a hummer, no mistake about it."

The foregoing appeared in the editorial columns of the Salt Lake Times on Wednesday evening. It is a non-"Mormon" paper, and has no more affiliation or sympathy with "Mormon" Church than the Tribune has. But it has more sense and less venom, and it is, we believe, earnestly engaged in assisting to advance the material interests of Utah. If we do not mistake its position, the Times favors that unity of purpose and action among various classes of the community which will best promote the welfare of all, leaving to each church and party that freedom which belongs to it of right in its own peculiar sphere. If that is correct, such controversy as may arise with it on questions about which men are likely to differ, can be conducted in a friendly way, devoid of that bitterness and those disgraceful personalities which are the principal

anti-"Mormon organ. And will take facts and the exact language of an opponent as the basis of discussion, instead of manufacturing events and attributing to an antagonist words he never uttered, which is the common course of the libellous Tribune.

The paragraph quoted and commented upon by the Times bears to readers at a distance the impression intended to be made by the writer. That is, that life and property are unsafe here, and that the "Mormons", are a set of assassins, full of hatred towards "Gentiles" and particularly towards United States officials. 1t delights in taking up some aucient occurrence, drawing upon its imagination or large stock of invention for lurid coloring, and so transforming facts that they are in effect almost the same as pure fiction. When challenged for proofs it responds "Oh! of course we cannot establish this by a proof that all the world can see, but it is true all the same, for a reliable person told somebody so and he told it to some one else and it was brought to us; what more would you have?"

Nearly everything which the 7ribune pretends to relate as well known lucidents of Utah history is fabricated in that way. The records of the Police Court in the dead issue now revived. will show that the Chief of Police acted under a warrant from the Justice, on a complaint duly sworn to and in accordance with law in every particular. The myth about the Apostle's "orders" has no substantial foundation and is an absurdity on its face. The other so-called facts are garbled, twisted, painted out of the semblance of truth and brought out of their mouldy obscurity as a pretext to justify still further attacks upon the "Mormon" people of today.

The original charge against the Tribune which these perversions of ancient history are intended to cover up, remains the same, unrefuted, half-confessed; namely: That the misrepresentations published as "Mormon" utterances in a New York illustrated paper are chiffy echoes of Tribune falsehoods. And the reasoning which it attempts to obscure still holds good; that is: It is all very well for public men to protest against the vile attacks upon Utah of a paper at a distance, but consistency would suggest a stronger protest against the libels of a pestilent strifebreeder and bullying obstructionist at home.

The welfare of the Territory and the progress of its people demand a change as to these matters and a unity of

it uttered, for the very purpose of rekindling those smouldering animosities that if left untouched will of themselves die out. To promote prosperity we must have peace.

A TERRIBLE CRIME.

THE account given by American Horse of the account of the massacre at Wounded Knee, which will be found in our dispatches from Washington, confirms the dreadful story that has already reached the public ear.

In spite of the sneers and sophistry of the apologists for those soldiers who committed the slaughter, it is clear that the shooting down of women and children was inexcusable. The plea of avenging the Cluster affair is entirely unavailable. There is no parallel between the two cases. The pretext that squaws and boys can shoot and stab will not meet the issue, for the evidence shows that groups of unarmed women and little vabies were slaughtered by the bloodthirsty troops.

It is a terrible episode in the needless and shameful conflict provoked by the whites. And the complaints of starvation, short ratious and poor supplies, showing the rapacity and callousness of the white agents and others, are a sad commentary upon the policy pursued toward the unfortunate remnants of the Indians tribes.

It is useless to belittle or attempt to palliate these crimes. They are without excuse hefore the Almighty and all just meu. Eternal retribution will be found to be an abiding principle, and the nation which commits or permits these things will be sure to reap the consequences of such a course.
