MRS. EMERY WINS IT.

Chief Justice Barrett Decides an Important Legal Contest.

THE QUESTION OF A TRUST.

The Court Finds Against Robert C. Cleaver, the Plaintiff in the Action.

An important and finally settled question was rendered by Chief Justice Barrett in the case of Robert C. Cleaver, the plaintiff in the action, against Mrs. Emery, the defendant.

The case arose from a will made by Mrs. Emery in 1888, which provided that the bulk of her estate should go to her son, Robert C. Cleaver, but that a trust should be created for the benefit of her daughter, Mrs. Emery.

The question was whether the trust was created by the will, and whether it was binding upon the estate of Cleaver after his death.

Chief Justice Barrett ruled in favor of Mrs. Emery, holding that the trust was indeed created by the will, and was binding upon the estate of Cleaver.
