Who is to compel the appointment. Why, it will be answered, there is a guaranty binding the company to make it. Just so. But is that guaranty any more binding than the law which requires damages to be paid? And do railroad corporations always honor what the law or a guaranty specifies, without litigation? We have not so learned by experience or observation. Such a guaranty would

observation. Such a guaranty would probably hold good enough under the present management, but on the ac-cession of another, it might not be worth a puff of mountain wind. Now, if the interests of the citizens along the line of the canal should be-come jeopardized by the railroad on its bank, and troubles should aruse that could only be settled by expensive law-suits with a powerful corporation to oppose, would not some of the very persons who now blame the city for not-granting the right of way, cry ont not granting the right of way, cry out against the city fathers who helped to put them into the dilemms, by giving the company privileges thus misused? We believe they would.
