Commissioner Lannan of Utah brought the matter up. He produced a letter written to Messrs. Lyon & Healy of this city, musical exhibitors, by Miss Heischick, one of the members of the Thomas orchestra, stating that she was very sorry she could not use a Lyon & Healy harp, which had been tendered her, because Director Thomas had notified the harpists that the Lyon & Healy harp could not be used in his orchestra.

Then Commissioner Lannan produced another letter to the same firm from another harpist, Edward Schuckert. This young man stated flatly that if the first expected him to take any interest in their harp, they must guarantee him a fee of \$1000 a year and in percent on every harp sold through his influence. Furthermore, he must have two new harps placed at his disposal.

The reading of these letters was the cause of a great sensation among the commissioners. Mr. Lannan said the matter should be thoroughly investigated and if the evidence in the letters proved true the commission should remove Mr. Thomas.

Berlin, May 4.—The discussion of the army bill was continued in the Reichstag today. Bismarck, the leader of the Freisinnige party, vigorously denounced the measure, and Caprivi upheld it. Bismarck, the social-democratic leader, repeated and emphasized the argument of Caprivi. After a short debate the Reichstag adjourned, and numerous party caucuses were held.

DIAMOND FOUND.

Probably a Case of Smuggling Jewelry into the Country.

INDIANAPOLIS, N. Y., May 4.—A young woman, who within the past few days has passed her time in the city, was arrested tonight in a grand street jewelry shop. The police went to her home and on the third floor found a Frenchman, who said that he was the woman's husband. The apartment was searched and more than 1
