Dear Sirs.—There was a snow-slide in Big Cottonwood Canyon yesterday morning, Feb. 5th, from the north side of the mountain. A portion of the slide is still there, where some wood-siders were sleeping, burying three of them, named Edward Samuels, William Hampton and John Holder, and killing the two first mentioned. The third, John Holder, though a wood-sider, Wm. McFee and others were dug out alive.

The melancholy accident has caused a deep gloom upon the families left behind by these men, and who mourn their loss, which is deeply felt. Bro. E. Samuels leaves a wife and three children, and Bro. Hampton a motherless and now fatherless child.

The bodies were brought home last night by the brethren, and the funeral of the deceased will take place to-morrow, Feb. 7.

Utah has an superior article, owing to the purity of the pasture, &c. All who are interested therefore should not forget to attend the convention."

It is cultivated in California, Spain, and old Spanish American colonies under the name of alfalfa. It does very well here, very well upon beach lands, when the grasshoppers will let it have fair play, and is worthily cultivated by our farmers, especially in the valley, and some portions of the eastern States. It is considered a more valuable forage plant. Red clover also flourishes well on our beach lands. But it requires more moisture than lucern, the clover being more succulent, and the red stalk and more branching and fibrous, and more fibrous in root than lucern or alfalfa. Both plants are very valuable.
