

YANKEE IN AUTO CAPTURES MULES

Thrilling Runaway With Spectacular Finish Occurs in Lower Main Street.

CHAUFFEUR IN NOVEL ROLE.

Instead of Causing the Whirlwind Affair, Driver of Motor Car Chases and Seizes Speeding Animals.

Gilbert Sharp, driver of one of the teams engaged in lowering the grade of upper Main street in front of the temple, was run over this morning about 10:30 o'clock, the rear wheel of his heavy wagon passing over his ankles, both of which were badly bruised but not broken.

Sharp had just dumped a load of dirt on Fifth South street, where the surplus is being hauled, when the team, a pair of mules, started to run. He was at the side of the wagon and was thrown partly under, and his legs would not have been broken had he not been lying on the loose, soft dirt. E. McNichols, a fellow teamster, seized the lines and tried to guide the mules into a telephone pole, but they deftly cleared it and McNichols landed against the pole, losing his hold.

There were many narrow escapes of pedestrians, bicyclists and persons in vehicles as the runaways now going at high speed, dashed down Main street towards the Salt Palace. At Seventh South the wagon all but struck an auto driven by Elgin Yankee, who was going northward. Yankee quickly turned his machine and went chasing after the runaways. It being an instance when scorching was entirely justifiable. Driven along by the mules, Yankee seized the lines and brought them to a stop in short order. Meanwhile Sharp was cared for by passersby, but, aside from being painful, his injuries were not serious. In less than half an hour he was loading up again, but expressed a determination to place no confidence in mules in general and that span in particular.

POMPIER FIRE DRILL.

Firemen at Station No. 1 to Work With Ladders Daily.

Beginning tomorrow morning the firemen at station No. 1, headquarters, will be kept busy for a couple of hours each morning going through the summer ladder drills.

From 10 o'clock to 12 each day the pomper crew, under Capt. Moreton of the ladder truck, will use scaling ladders on the tower at the rear of the station. They will climb to the top of the tower with scaling ladders, use the big aerial truck, carry up hose, use the life net and practise carrying persons from an imaginary burning building.

Chief Vail is anxious to increase the efficiency of the pomper crew as it is one of the most important departments of the fire fighting system. It serves to keep the men in splendid physical condition and teach them to be cool and prompt in cases where lives are in danger. There will also be hose drills and signal work for officers and men.

CAN NOT TALK TO CILENT

Attorney Bailey Invokes Aid of Judge Diehl in Deming's Case.

The case against Richard Deming, the convict-desperado serving ten years in solitary confinement for robbery and subsequent assault upon a fellow convict at the state prison, and now charged with attempting to break out of the county jail and destroying jail property last January, was called before Judge Diehl this morning for preliminary hearing, but upon motion of

counsel for defense the case was continued until Saturday morning, at 9 o'clock.

Deming was represented this morning by Bailey and Vickery, the youthful attorneys who defended Joe Sullivan, now serving a life sentence for the murder of Police Officer Charles S. Ford.

In making his request for a continuance, Mr. Bailey said:

"We have been denied the privilege of consulting with the defendant in private. The prison officials refused to permit us to talk to the accused alone, and as we do not feel like letting the prosecution know what our defense will be, and as we propose to summon witnesses for the defense, we feel that we should have more time. If necessary we will ask for an order from Judge Armstrong permitting us to talk to the prisoner alone."

Deming was brought from the state prison by Deputy Warden Ure. The fellow was securely handcuffed to a belt surrounding his body and was carefully watched by the prison official. As the officer and his prisoner left the court room, Atty. Bailey sought to have a private interview with him, but this Mr. Ure would not allow.

Deming then returned to court and demanded that Judge Diehl issue an order permitting him to talk privately with Deming. By this time officer and prisoner were on their way out of the building. They were called back, however, while the matter was being discussed. Judge Diehl was not certain that he could make such an order in view of the fact that Deming was committed to the state prison by order of Judge Armstrong. Assistant County Attorney Farnsworth expressed the opinion that, as Deming was now in Judge Diehl's jurisdiction, he could make the order if he saw fit.

The order was then made, but Mr. Ure refused to permit Deming to be taken out of the court room. This was followed by a long whispered conversation between Bailey and Deming, after which the man was taken back to the state prison. What his defense will be is a matter of conjecture. It is known that Deming wants Joe Sullivan to testify in his behalf. If the latter says he, and not Deming, tried to saw out of jail, Deming may be charged with perjury because on the occasion of Sullivan's trial for murder, Deming testified that he saved the bar.

TO FIGHT PROHIBITION.

Retail Liquor Dealers Meet and Organize at the Eagles' Club.

The retail liquor dealers of Salt Lake have formed an organization to combat the prohibition wave which they consider is about due to reach this territory in its progress over the country.

At a meeting in the Eagles' club last night, 30 retail liquor men talked the situation over, decided upon a permanent organization, and elected H. S. McCann, secretary of the Eagles' club, temporary secretary. It is the purpose of the association to exert an influence in politics and to try through this medium to prevent the passage of anti-saloon laws.

U. P. BOND ISSUE IS NOW AFLOAT

Intersting Details Given Out by New York Bankers Regarding Sales.

PUBLIC MAY PARTICIPATE.

Figure Set at 96 for \$50,000,000 Offer, ing as First Lien and Refunding Mortgage, 100 Year, 4 Per Cent.

The Union Pacific bond issue is afloat and the price to the public is 96. This much is known generally, but details of the placing of the \$50,000,000 worth of bonds, which are not so generally known, are of considerable interest. Both E. H. Harriman and Kuhn, Loeb & Company, have made formal announcement of the negotiations for the sale of the bonds, which are first lien and refunding mortgage, 100-year, 4 per cent gold bonds. The taker was the International company, headed by New York bankers and comprising Baring Bros. & Company, and Glyn, Mills, Currie & Company, of London. A meeting of the U. P.'s executive committee was held to ratify the sale and at this gathering the amount of the issue was raised from \$40,000,000 to \$50,000,000. This is a part of the \$100,000,000 issue authorized by the U. P. stockholders last month.

Kuhn, Loeb & Company say \$25,000,000 worth of bonds will be offered in the United States and another \$25,000,000, in the form of sterling bonds will be offered for public subscription in England. Kuhn, Loeb & Company refused to admit the international syndicate paid \$2, and is planning to offer at 95 1/2. It is said Harriman held out for 94 early in the transaction, and was finally offered either 93 or 93 1/2. This compromise was accepted, and the price of the official sources, from New York and London came down to the reports that the Rothschilds refused to participate in the flotation of the bonds because of the charge of vagrancy against them. In fact, London says the Rothschilds look upon the transaction favorably. It is understood the whole cause for reports of differences between Harriman and the Rothschilds was the former's refusal to grant any concession in price of bonds to gain any prestige the Rothschild participation might lend to the transaction. "The bonds are very cheap compared to the market and credit of the Union Pacific," said Mr. Harriman, and that was an end of all discussion. Those who want to buy at market price can do so; those who feel they ought to get a better price, to discounting towards the market, are disappointed. Prices in New York have ranged from 96 1/2 to 97 1/2, the bonds selling strong at the highest figure and brisk at lower marks.

Board of Governors of Commercial Club to Decide This Week.

Friday morning the people of Salt Lake should know the outcome of the struggle of a local arm of architects for the honor of building the Salt Lake Commercial club's new home, against competition from New York. Thursday evening the two sets of plans handed in will be considered by the board of governors, the finance committee and the building committee of the Commercial club. One is from Henry Ives Cobb of New York, the other from Wade & Tregan of Salt Lake. The petition ended some weeks ago, but action was postponed owing to the absence of Chas. Wright on the coast. Following the selection of plans, the building will be rushed at once to completion, excavation on the cellar commencing within a month.

Wednesday evening the Commercial club freight bureau committee will meet to discuss the plan of the building drawn up to form a regular bureau in the interests of local shippers.

FAMILY STRANDED HERE.

Man and Wife, Four Children and Two Dogs Ask Assistance.

G. W. Allen with Mrs. Allen and four children, appeared before Pauper Clerk A. Lundberg this morning and said he was absolutely penniless and without means to support his family, and appealed for assistance. Allen said he was a wood chopper, and appears to be almost helpless and hardly knows what to do. His family consists of Mrs. Allen and two boys and two girls, and two dogs accompany the group, to which are attached chains and piloted about by one of the boys. Allen said he would sooner suffer himself than to see the dogs go hungry, so the assistant asked for included help for the dogs. Since arriving in this city several days ago the family have been staying at the Wellington hotel. Clerk Lundberg informed the man that he was in no wise a charge of the county, and that the best he could do for him would be to assist him in finding work. The family came here from Lane county, Oregon, where they sold everything they had and started out to find a new home, but became stranded shortly after reaching this city.

DEVELOPS NEW "WORM."

Clerk Hansing of Health Department Makes Great Discovery.

F. L. Hansing, clerk of the city board of health, has made a new discovery in "bugology." Mr. Hansing is an enthusiastic fancier of fine dogs, and possesses some good specimens of pedigree canines. With the purpose in view of compounding a preparation to relieve his pets from parasites, in the way of fleas, etc., Mr. Hansing got together a number of ingredients of pedigree canines, and would prove to be "sure death" at 40 rods to anything in the "microbe" line, and began to experiment with it. His preparation consisted of the following materials: Rain water, 1/2 bottle; 1 lb. of sulphur flour; 1 qt. sulphuric acid; 1 can concentrated lye, and 1 pint creosote. A portion of the compound was bottled, to note the effects of the liquid upon the inside of the bug tribe, and after it had stood a while, what was Mr. Hansing's surprise to note that a number of horrible looking, slimy, worm-like objects developed in

the liquid, and grew with marvelous rapidity until they had attained the length of an inch in body, and with a feather-like tail of probably another inch in length. Some 20 of these slimy fish-like growths have developed in the bottle, and they are now on exhibition in the office of the superintendent of schools in the city and county building. The bugs are of a mottled gray color, and appear to be blind.

CHICKEN THIEVES OPERATE.

Chicken thieves are still abroad in the land. Last night a thief, or thieves, entered the coop of John McDonald, 651 south Ninth West street and stole nine valuable chickens. The thieves worked quickly and quietly, as the family heard no disturbance during the night. The matter was reported to the police this morning and they are making an effort to recover the fowls.

ORDERED OUT OF TOWN.

W. T. McCoal and James Henry, two men arrested by Detective George Sheets yesterday afternoon, were given "boaters" this morning by Judge Diehl on motion of Asst. City Atty. E. A. Rogers. The latter and the police officers preferred the room to the company of such men as McCoal and Henry. The fellow pleaded guilty to the charge of vagrancy and were given until 2 o'clock this afternoon to leave the city. Detective Sheets stated that the men are professional thieves, but unfortunately he had no other charge than vagrancy to lodge against them at this time. The authorities acted upon the theory that it is better to rid the city of such men before they can do any crooked work.

POLICE FIND OPIUM DEN.

Patrolmen Simpson and H. D. Lyon were called to 87 Franklin avenue this morning, where it was reported a negro was beating a woman in an attempt to kill her. When the police arrived they found the place deserted, but concluded to make an investigation of the premises. In doing so they ran across several opium "joints" and were convinced that the place was a resort of opium smokers. The officers found no one connected with the place and no arrests were made, though the paraphernalia was confiscated by the police.
