#### MESSAGE SENT TO CLARK.

#### Meeting of Directors in Salt Lake Terminates This Morning-Officials Scattering to Various Points.

The directors' meeting of the San Pedro, Los Angeles & Salt Lake terminated this morning. Senator W. A. Clark left at 9:45 a. m. for Butte. By tomorrow morning there will not be a non resident director remaining in Salt Lake, providing Vice President T. E. Gibbon can complete the few details which he has to attend to in that time. When seen after the meeting this morning Mr. Gibbon stated that there

was nothing to give out for the information of the general public; the brief session held this morning, he said, was mainly devoted to the passing of some resolutions.

The afternoon session of the board The afternoon session of the board yesterday lasted for three and a half hours and was mainly devoted to the reports of Mr. Gibbon and Engineer McCartney. Mr. Gibbon laid before the meeting the reports in the Pomona and Carson City suits, also his plans re-garding pending condemnation suits. The financial reports were also inter-esting and a showing was made where-by the company has set forth as hayesting and a showing was not has be by the company has set forth as hav-ing spent in the neighborhood of one million dollars for the purchase of roll-ing stock, equipment, legal expenses in-curred in securing right of ways, and

grading expenses. Mr. Gibbon this afternoon stated that if it is possible to get a quorum to-gether that another directors' meeting will be held in Los Angeles within the next ten days.

DENVER WANTS THE ROAD.

During the progress of the meeting of the directors in this city numerous telegrams have been received by Pres. ident W. A. Clark from all over the West in which support of the enter-prise is promised. Among the most significant that were received by the millionaire railroad promoter was a long message from the Denver chamber of commerce and board of trade. signed by its president. Mr. Gibbon stated this morning that the dispatch consisted of a long resolution, the pur-port of which was that the residents of Colorado in general and Denver in particular were deeply interested in the project and desired nothing better than to be put into direct railroad connection with the harbor of San Pedro, and with their end in view the Denver cham-ber of commerce would do all in its power to further the scheme. The telegram promised hearty support to the San Pedro road, and went on to say that the project would receive active co-operation on their part. Valuable data is also offered to be placed at the disposal of the company. In the face of the message and developments that are shaping with the Colorado Midland, which is outside the Harriman-Gould combination, it stated in some quarters that there is something very significant in the dis-patch from Denver. 

### DIED IN A SALOON.

trange Death of an Italian Woman-Inquest Tomorrow.

Aff Italian woman named Amelia De regario, who came to this country bu recently, died suddenly and under mysterious circumstances in a back room of an Italian saloon on State street near First South, last night. The woman was 41 years of age, and came to Salt Lake two weeks ago. About a half an hour before she died

she was seen to accompany a stranger into one of the rear rooms. She had been drinking considerably but other-wise her condition was not such as to excite any notice whatever.

Joe Falsetto, the bartender of the place, says that he heard the woman screaming and hastening to the room saw the woman rush into the street clutching her throat and gasping for breath. Her companion rushed through the saloon and disappeared, and no trace of him has been found. Falsetto assisted the woman back into the saloon and summoned Dr. C. M. Benedict, but before he arrived the unfortunate womar died. The bartender claims that just before she died she told him that the stranger caused her condition while in his embrace, but it is said by her associates that she suffered from consumption and has been ill for sever-

al days. The body was removed to the un-dertaking establishments of Joseph Wm. Taylor, and an inquest will be held in Justice Dana T. Smith's court tomorrow morning at 10 o'clock.

#### STRIKE SETTLED.

#### Philadelphia & Reading Railroad Ignores the Labor Union.

Philade'phia, July 2.-President George F. Baer of the Philadelphia & Reading Railway company has given out the following signed statement: "The Reading Railway shop strike has been settled upon the following

"The men to return to work at once just as they were before they went out. "The men to be restored to the Phila-delphia & Reading Relief Association with like effect as though they had not left the employ of the company.

The labor union not to be recognized. We will employ any one we please and no distinction will be made between union and non-union men.

"After the men have returned to work a committee of the shops, representing all the workmen can be appeinted by our employes. We will appoint a com-mittee composed of superintendents and foremen of the shops to meet the work-men's committee and the whole subject of wages to be considered by this joint committee with power to agree upon a new scale of wages which shall be fair and just both to the men and the company. These committees are to begin work as quickly as they are slocted. In case, after a reasonable effort, the joint committee cannot agree, I will person-ally meet the joint committee and endeavor to adjust the differences. understood that if any new scale is agreed upon it shall, whenever adopted, be effective July 1, 1901. Transportation will be given to the committee to visit any of the shops with a view of accertaining the scale of wages in force in such shops."
