## THE CARNEGIE SETTLEMENT.

THE telegraph informed us a day or two ago that the monster strike at the Homestead Works of Carnegie & Co., Pittsburg, had been settled amicably, both sides making some concessions. It will be remembered that the men demanded an advance of ten per cent in their wages, as was promised them before the election in case the Republican party prevailed, and as it prevailed and they helped to make it prevail, and for the further and more potent reason that they were unable to live decently on what they were getting, their they put demand shape and called proper Carnegie's immediate attention He took their appeal to it. under advisement, and finally responded by informing the men that "under the circumstances" would have to reduce wages fifteen per cent! This was asking for bread and obtaining a stone sure enough. There were, however, but two things to be done: to accept the reduction or quit working. latter course was decided upon, and as one man they all deserted their posts, leaving the works at a standstill. This was a great loss to the company, but it was actual starvation for the workers, so it is not difficult to imagine from which side the greater part of the concessions came.
