

### STRANGE SERMON ON LYNCHING

The Rev. Dr. Bartlett of Chicago Justifies the Crime.

### SHUDDER AT WRONG PLACE.

"The Spirit Which Causes the Uprising is the Reflection of a Higher Civilization."

Chicago, June 28.—"I am no advocate of lynching or of mob law, but I had rather see a community wrought to the highest pitch over crimes that would seem impossible this side of hell than to remain apathetic," was the declaration of Rev. Dr. Bartlett at the First Congregational church today, in a prelude on "Lynching from another point of view." Dr. Bartlett said: "I have seen so many sermons, editorials and resolutions denouncing lynching and mob law that one gets the impression that the citizens who hang or burn the destroyers of life, home and all that is held sacred by womanhood are the offenders, rather than the monster within their souls."

"We seem to be so absorbed with the majesty of this vague term 'law' that the notion appears to prevail that the real criminals are those who do not wait for legal processes, and the violator of womanhood is the abused party."

"We shudder at the torture of the criminal who is burned, but apparently forget to shudder for the innocent girl, whose mental and spiritual agony is far greater than that of the criminal. This is not a race problem, except so far as one race are the offenders. The white man who commits the crime is just as guilty."

"The indignation arising of a community, and some of the best men in it, to avenge a wrong of such awful magnitude may be technically lawful, but the spirit which causes the uprising is the reflection of a higher civilization. There are crimes so dreadful that the pure and the chivalrous and the strong find it well nigh impossible to endure the thought of such a degenerate state polluting the earth by its presence. It is easy to theorize about the anarchy of mob law, but the same hand which penned the divine edicts might be the first to grasp the torch if it was a mother, wife or daughter who was the victim."

"I say that when you look at lynching from another standpoint, it is simply the bursting forth of an indignation and loathing that will not be checked. In the Old Testament days they made short work of such an offender."

"Lynching is certainly a bad method, and forms a habit of disorder and anarchy which should be avoided. It is to be avoided there is certainly cause for a more sure and speedy trial of those wretches who often brazenly deny crimes amid the red tape of legal procedure, but confessing objects when confronted by determined men. It is useless to bring to trial good men who rise to protect their friends. The community will not be better if the object to be burned let them escape from crimes which make a nation sick."

### MURDERED HER HUSBAND.

Mrs. McCann Swears Out Warrants Against F. S. Barrington.

Crime Alleged to Have Been Committed in St. Louis County, Mo.—  
Wife's Antecedents.

St. Louis, June 28.—A warrant was sworn out today by Mrs. James P. McCann, charging F. Seymour Barrington with the murder of her husband, James P. McCann. As the alleged crime was committed in St. Louis county, the city authorities today gave Barrington over to the custody of Sheriff Hankson, and the prisoner was taken to Clayton and placed in jail.

The body of the man supposed to be McCann, which was buried soon after being discovered several days ago at Bonita, was exhumed today and an inquest was held by Coroner Koch of St. Louis county. The body was in a terrible state of decomposition and the features were gone, but the bones were of vermin. Notwithstanding, Mrs. McCann positively identified the body as that of her husband, partially basing the identification upon a gold tooth. Others who knew McCann intimately also identified the body.

Coroner Koch made a rigid investigation and returned a verdict that two bullet holes were found in the dead man's head and the bullets were extracted corresponding in character with the caliber of the revolver in Barrington's trunk at the Union station here last night. He also found a deep gash in the throat and a cut in the palm of the right hand, leading to the assumption that the man had been attacked first with a knife and in defending himself had seized the blade, which cut deeply into his hand; that finally his throat had been cut and that he was ultimately shot twice in the head. Barrington maintains his innocence.

MRS. McCANN.  
Lexington, Ky., June 28.—James P. McCann, who was killed at St. Louis, was of a prominent family here. His father was a prominent horse breeder. Two sisters live near this city, and today R. T. Hume, a brother-in-law, here to St. Louis to bring his remains to Lexington. McCann's wife was Miss Callaway of Owensboro, Ky. Two weeks ago he sent his sisters photographs of himself, wife and F. S. Barrington. He was devoted to his wife.

ANGLO-CHINESE TREATY.

London, June 28.—The Times correspondent at Peking says it is announced that the ratification of the commercial treaty between China and Great Britain, which was signed by Sir James MacKay and the Chinese commissioners at Shanghai last September, is on its way to Peking, and ratifications will be exchanged after its arrival, although China has not vouchsafed a reply to the queries of the British government regarding her intentions as to the carrying into effect of some of the more loosely worded clauses of the treaty.

Article 5 of the treaty provides for the abolition of the opium barriers, while the native customs-houses are retained. The functions of the opium barriers and the customs-houses are largely interchangeable. The treaty also provides that Great Britain must be furnished with a list of custom-houses, concern-

### A LOVER'S WICKED DEED.

#### Shot and Fatally Wounded Sister of the Girl He Loved.

Lowell, Mass., June 28.—Joseph Lamont, a clerk in the office of the New York, New Haven & Hartford railroad at Boston, tonight shot and fatally wounded his sister, Miss Alexine Goddu, aged 22, of Winchester, and Dr. Adelaide Payette, aged 35 years, of this city, and is still at large.

The shooting was the outcome of Lamont's infatuation with Miss Alexine Goddu, aged 22, a sister of Goddu's, and occurred in front of the residence of Dr. Payette, whom the Goddu sisters were visiting.

Lamont held Goddu's hand in conversation for over an hour, and when Dr. Payette came out of the house to prevail upon him to go away, the latter fired two shots, one of which lodged in Miss Goddu's left breast, while the other struck Dr. Payette in the groin.

Miss Goddu is in a critical condition and cannot recover, Dr. Payette will recover.

### TWENTY-FOUR ARE DEAD

And Fifty Others Seriously Injured as Result of A Gas Explosion in Coal Mines.

Occurred at Las Esperanzas—Gas Was Ignited by Flame from a Defective Lamp.

Baratobran, Coahuila, Mexico, June 28.—Twenty-four miners were killed and about 50 others seriously wounded in an explosion of gas Thursday night in Las Esperanzas coal mines, the property of the Mexican Coal and Coke company. The disaster was caused by the ignition of gas by the flame from a defective lamp.

The men were on the point of quitting work for the day. Probably 100 men were in the mine at the time of the explosion. After the shock of the explosion those who were able to move rushed to the exits, but the falling earth and debris carried many down to death. Fully fifty miners escaped with broken limbs and scorched flesh.

At last reports the dead bodies of 24 men had been brought to light. Others may die as a result of their injuries.

### COMET WITH TWO TAILS.

Discovered by Berrelli and Photographed by Lick Observatory.

San Jose, Cal., June 28.—The following report was received from Lick Observatory this evening. The conspicuous white spot on Saturn, which was observed at Lick Observatory on Wednesday, was not again in a favorable position for identification until Sunday morning, when it was looked up at Lick Observatory. The spot appears to have divided too far to be easily distinguishable.

The comet discovered by Berrelli a week ago at Marsella, has been regularly observed with the 12-inch telescope at the observatory. It has also been fully photographed with the long exposure, showing two tails. This is an unusual occurrence, as only about one comet in 20 is so situated as to permit of this direct measurement. Its nucleus is about the brightness of a 12th magnitude star.

It lies due south at 3:30 in the morning, 13 degrees above the horizon, and is about three-fifths of the way up to the zenith in the constellation Aquarius.

### Mount Colima Still Erupting.

San Francisco, June 28.—Recent reports received here show that Mount Colima is still in state of eruption. Steam and smoke continue to pour from the mouth of the crater and loud rumbling is incessantly heard. Great masses of ashes have been thrown from the mouth of the crater, falling on the slopes and sliding down the mountain side, but as yet no lava has been issued from the mountain.

### SALT LAKE TEAM IN P. N. LEAGUE

Action Will Probably be Taken at Meeting at Tacoma Tonight.

### REPRESENTATIVE THERE.

C. H. Griffin Will Look After the Interest of the Local Team—Team To be Dropped.

Tacoma, Wash., June 28.—Magnates of the Pacific National league are gathering in Tacoma tonight for the league meeting to occur tomorrow. There arrived today Harry J. Hart, owner of the San Francisco club, accompanied by his attorney, M. I. Schmitt of San Francisco; J. M. Reynolds of Butte, W. E. Perrell of Helena, and W. V. Garrett of Spokane and Ed. H. Griffin, who represents Salt Lake City. D. E. Dugdale of Seattle and Dr. Emmett Drake of Portland are expected tomorrow morning. There seems to be no doubt that the Portland club is to be ultimately transferred to Salt Lake. All of the Salt Lake magnates now here favor his move. The Portland club is said to have been financed this year entirely by the other clubs of the league, leaving the league free to make the transfer if it sees fit. The important question to be settled is whether the Salt Lake club will cut it loose from the two California clubs.

Mr. Hart says he does not believe his associates will be guilty of such an act of chicanery as to bring into the game with eyes open, knowing that they would have the franchise in the Pacific National league. There seems to be nothing in the way of a realization of the dream of Salt Lake to purchase the franchise. It means that this city will have better baseball than it has ever seen in the history of the national game. The magnates of the Pacific National league met at Tacoma this evening and the matter of granting Salt Lake the coveted franchise will be taken up. This city has a representative on the grounds who understands the game and the game is being played from Alpha to Omega. He has full power to act for the local club and is supplied with the necessary coin to purchase the franchise. The local team will demand that which has been promised. It means the pick of the players from the team dropped and Buck Weaver's release from the San Francisco club to manage local affairs. Just which team is to be let out of the league will not be known until after the meeting of the directors tonight. It is said by those who should know, that in all probability Portland will be the club to fall. Then again it is intimated that it will be Helena.

Further declared that Los Angeles and San Francisco will be dropped and a new league organized in California for the purpose of fighting the outlaws to a finish. It will be made up of San Francisco, Los Angeles, Oakland and Sacramento. The organization of which this city will be a part will be composed of Salt Lake, Butte, Spokane, Seattle, Tacoma and either Portland or Helena, probably the latter. It is intended that the league will operate on July 1, and then the fans will have the pleasure they have waited for.

What will happen to Ogden is not known. It is not hard to guess. Either team in the local organization may drop out by giving 10 days notice so that the local club will have no trouble on that score. There is some talk to the effect that a strenuous effort will be made to have Ogden admitted to the league but there is little likelihood of such action for the reason that the directors do not want the functionary club out of the league support team in the league. If the Ogden team disbands, then Salt Lake will have the teams to pick players from. They will be the local Ogden and Portland. If that team is dropped, we can certainly have a winning team.
