LOCAL AND OTHER MATTERS.

DESTRUCTIVE.—Considerable damage is being done in the fields south of this city by cattle turned down there by their owners. Corn, potatoes, sugar-cane, and other late crops, have suffered severely from this cause. A person who will persist in feeding his stock at the expense of other people is, to say the least, not overburdened with honesty. The practice should be stopped and offenders severely punished.

RENOVATING.—Our reporter stepped into the City Hall to-day and found Marshal McAllister busily engaged in superintending the thorough renovating and general metamorphosing of the mayors office.

REMOVED.—Dr. J. P. Meik, homeopathic practitioner, has removed his office from the DESERET NEWS building to his residence on First South Street; where he can be seen and consulted at nearly all hours. HEAVY YIELD.—The *Missoula Pioneer*, a paper just started in Montana, records a "heavy yield" of grain in that country. One man's crop of wheat averaged thirty-four bushels to the acre, and his oats fifty bushels per acre, which is the heaviest yield in the country. This may be a "heavy yield" for Montana, but "we can beat it all hollow" in Utah.

UTELING ON BACKING.—There are some very contemptible persons in this city who seem, like the Provo raiders, to rely a good deal on the "backing" they think they will receive in their efforts to override the territorial and Municipal laws which have so long obtained in Utah. A number of petty cases of persons charged with selling without license &c., which come within the purview of the Alderman's court, have been appealed from that to the District Court. We cannot imagine any reason for these small persons taking this course other than on account of the expectation of being backed and the judgment of the Alderman's Court overruled and set aside. Further developments will prove whether the ideas of this insignificant crowd are correct or otherwise. We can scarcely think however, that certain persons in position to overrule quite so low as to make the expectation a reality. Still we are prepared for almost any effort on the part of some persons to lord it over, outrage the feelings and destroy the privileges of the citizens of Utah. There is an oft-cited passage in Shakespeare's writings to the effect that "Man, clothed in a little brief authority, plays such fantastic tricks before high heaven, as make the angels weep." Whether we have got such officials in this Territory all the people of Utah and all the world can judge. In passing judgment upon such abusers and maladministrators of official power it is only necessary to scan their careers. Representatives of free Republican institutions indeed, pah! Here are thousands of American citizens whose united voice and wishes can be ignored and overruled by the opinion of a man sent here and thrust upon the people against their will. Speak of the despotic rule of monarchs after that! Why, this course, which was adopted by the English Government towards the Colonies, was the cause of the flames of the revolution burning forth over the entire land; this course pertinaciously pursued by the English government was the first cause of the standard of freedom being reared and refuge being opened for the oppressed of all nations. Law-breakers may be backed in their nefarious efforts to avert the consequences of their knavishness; and the officers and courts of the people may be ruled out for a time; but this will not last away. The evil alluded to is one that is calculated to grow if fostered by judicial administration, and is only one out of a host that will grow out of the system of things lately inaugurated here.

NEED AID.—The Gold Hill News, of last Monday, is responsible for the following: "Tucson, the capital of Arizona, with a population of 2,500, has neither school, church nor minister. We don't see how our Nevada friend, Governor Sedgwick, can content himself in such a heathen community. He was a Christian when he lived in this State."

If true, the above statement shows that the condition of any one might be improved. With "neither school, church nor minister," the white folks there will soon be very little, if any, better than barbarians, and this wretched state of things doubtless accounts for the continual warring and fighting between the white and copper-colored residents of that State? What is the Miner about?
