It will result in great benefit to the sugar industries of the west and will encourage the rais-ing of sugar beets and will eventually mean the establishment of more sugar factories in the west." factories in the west."

W. S. McCORNICK.

W. S. McCorick said, "There is but one view to take in Utah; it was em-inently proper for the senate commit-te to do, and it will add materially to the value of the beet sugar interests throughout the intermounain country. I believe that the consideration of the proposed bill added largely to the de-pression of sugar stocks. The failure proposed bill added largely to the de-pression of sugar stocks. The failure of the legislation will greatly encourage the beet sugar industry, and have a buoyant effect on its stocks. Its suc-cess would have brought the Philippine sugars in direct competition with all western sugar interests and with dis-pstrous results."


WHAT BROKERS SAY.

E. L. Burton, the well known broker, said, in response to questions from a "News" representative: "My opinion has always been that this is not so much a Philippine proposition as it is a fear of what might happen in the sugar markets of the United States if sugar markets of the United States if the Independent Sugar company of San Francisco should get to refining Ha-walian sugar there. This company will handle about 80 per cent of the Ha-walian product, and has been getting 10 years contracts from the growers in these islands. Now, should these sug-prs be shipped to San Francisco for refining, the question arises: Will not this sugar be distributed in the western country, and thus invade the beet sugar territory? And in this event, what will become of prices? That is what will hurt our sugars. will hurt our sugars.

will become of prices? That is what will hurt our sugars. "Then there is another thing. The low extraction from the beet this has season has been a source of depression in the industry; but fortunately this will not be permanent. This was due to the withering of the leaves by a pest which appeared about the same time as the tomato blight. The larger and broader the leaf, the greater the secre-tion of saccharine matter; and when the leaves are in any way affected, the yield in sugar is also affected. More-over, there is agitation in certain dis-tricts among the farmers or growers for higher prices, and while most fac-tories have the usual contracts, some have not signed up within 50 per cent of the proposed national legislation will not affect the market, and in fact its passage would not have affected it either locally.
