Classes in vocal music will meet every morning; classes in instrumental music, on piano or organ, three afternoons weekly. A course of lectures will be delivered to the members of the institute, during its session by prominent lecturers connected with the musical and educational interests of the city. It is hoped that as many teachers as possible will avail themselves of this opportunity of acquiring a knowledge of this important branch of their work as public educators. The movement has the sanction of President John Taylor and is endorsed by Professor T. B. Lewis, Dr. Park, O. H. Riggs and others.

An Ocular Curiosity.—Mr. Thomas C. Thomas, of the 16th Ward, showed us a curiosity this afternoon, in the shape of a hen's egg, measuring 8 1/2 inches in circumference, lengthwise, and 8 inches in circumference the other way. It is quite a curious specimen.
