

LOCAL AND OTHER MATTERS.

Rain.—A gentle rain set in last evening, and has continued at intervals during the day. The clouds still hover as though promising more.

Immigrants.—By telegram from Wm. C. Staines, we learn that the company of Saints which left Liverpool for New York yesterday, arrived at New York yesterday, and left for the West to-day. All well.

Earthquake Shock.—Some of our quietest inhabitants experienced a slight shock of earthquake last night, shortly after 10 o'clock. It shook houses and articles of furniture, turned some persons slightly ill, and the sensation produced is compared to an electric shock.

Gone North.—This afternoon Apostle George Q. Cannon, Elders George G. and William W. Willes left for Logan to be present at the Sunday School jubilee to be held there to-morrow. Elder Cannon will remain and preach in Logan on Sunday, while the others will return to attend the jubilee of the Sunday Schools in that place. They will be joined on Sunday by Elder Samuel L. Evans, from this city.

Dusenberry, of Provo, met with a serious accident by falling headlong from a horse he was riding, and which stumbled and rolled over in the street. The boy was picked up in an apparently lifeless state where he had fallen, and it was found that his fall had caused a concussion of the brain. He was unconscious all night and part of the next day, but is now thought to be in a fair way toward convalescence. So says the *Expositor*.

The members of the Club in this play, the one in which they made their debut, will be well remembered, and we dare say that not only will our Conference friends desire to see the performance, but many of our own citizens as well.

Sunday School Picnic.—From L. A. D., who writes from Hebron on the 14th inst., we learn of a pleasant picnic enjoyed that day by the united Sunday schools of Hebron and Clover Valley, on invitation of Bishop Thomas S. Terry, at the farm of Brother Edwin Hamblin, on the head waters of the Beaver Dams, about 20 miles from Hebron and half that distance from Clover Valley. At 1 p.m. the Hebron party arrived at their destination, where they found the other assembly awaiting their coming. A fine feast was set out in a willow grove, to which all did ample justice, and at 3 o'clock, meeting was called. The combined choirs rendered a hymn; prayer was offered, and the congregation was addressed by Bishop Terry, Superintendent Lyman L. Wood, of Clover Valley, and Superintendent C. W. Hesterman, of Hebron.

The Situation at Beaver.—Mr. S. A. Kenner, of Ogden, returned last evening from his three weeks' trip to Beaver. He says there is a corresponding for legal practice in that county, and he will probably take advantage of it and settle there. He confirms the report of Boreman's contemplated resignation of his position as Judge of the Second District Court. His honor announced from the bench last Tuesday that the present term was his last in the district. This is a move that will be hailed with delight by the great majority of the people. No lawyer, who is not a radical "Mormon," enters the least show with Boreman on the bench. The Coombs contempt case will go over to the next term. It is believed that Boreman has already sent in his resignation, but it is yet uncertain who is to be his successor in office. As stated last evening, the returning Judge will come to this city to assume the legal business of Tabor and Hagan, whose clients, it is needless to add, are henceforth worthy subjects for commiseration.

The Fifteenth Ward Meeting.

House.—The 15th Ward new meeting house, which is rapidly being finished, is one of the finest halls in the city, and without question the nicest house of worship yet erected by any of the wards. It is built after the gothic style, and somewhat resembles a church, the material used in its construction being principally brick, with a granite foundation. In front of the building which faces north, is a vestibule measuring 16 by 12 feet, and surrounding the edifice are 14 buttresses. The outside dimensions of the main house are 71 feet long by 40 in width. There are two front doors, both of which open in the sides of the vestibule, and a pair of folding doors leads from there into the main apartment. This a fine commodious hall measuring 68 feet in length and 38 feet in width. The ceiling is 22 feet from the floor. It is arched from the east and west sides and has three elegantly moulded centre pieces of plaster, from each of which will be suspended a gas chandelier of 12 burners. The room is lighted by 13 large gothic windows, each 14 feet high, and at the south end are two ordinary doors which will lead into a vestry, when the latter is built. At this extremity of the interior is a stage of good dimensions and moderate height, upon which will be placed the speaker's stand, and the sacramental table. Immediately in front of the stage, at equal distances from the side walls, is a low platform for the choir. The hall is not yet furnished with benches, but will eventually have a seating capacity to accommodate between 500 and 600 persons. Above each of the main entrances, on a smooth stone tablet, is the inscription, "Later-day Saints' House of Worship, erected A. D. 1879, Fifteenth Ward." On the summit of the vestibule is a carved finial and another on the front gable of the main building. These as well as the doors, were carved by Brother Edward Bird, a resident of the Ward. The north gable has a circular frame containing a star-shaped or five-pointed window, opening into the loft. The meeting house was commenced a year ago last 4th of July, and not only has been built entirely by donations from the people of the Fifteenth Ward, but the workmen, with one or two exceptions, are all members of that Ward. It has cost, so far, over \$6,000, nearly all of which is paid up, and it will take about \$2,000 more to finish it. The mason work was done on contract by Elias Morris, the carpenter work was superintended by G. W. Price, the painting was done by Wm. J. Lloyd and the plastering by Wm. Jones. The building committee, to whose energy and commendable labor is greatly due the erection of this fine edifice, are Joseph Pollard, Elias Morris, Wm. L. Binder, John Clark, James Moyle and G. W. Price. We congratulate these and the members of the ward generally, on their possession of a structure which is a credit to them and an ornament to the city.

Woman's Exponent.—The *Exponent* for September 15th, to-day, presents its smiling face for our inspection. One of the leading articles is the editorial, "Visit of President Hayes and Party," well worth reading, and another that is prolific of good instruction is "Babyhood," by Hannah T. King. Helen Mar Whitney continues her interesting "Life Incidents," and the serial entitled "Ten Sketches of an Illustrious Woman," is also prominent. A selection from the *Woman's Review* is called "Xantippe—A Fragment." Kate presents us with some graphic pictures on "Married Life," very realistic no doubt, Jenny Jingle furnishes a gem of an essay on "Shaking Hands," and Salaome gives us a valuable lot of good "Home-spun Talk." Other short prose pieces and the usual correspondence fill in very nicely. The only poetical contribution in the number is "A Mother's Address to Her Children," written by Emily H. Woodmansee, for Sister M. I. Home, and addressed by the latter to upwards of 50 of her children and grandchildren, at a recent family reunion at the old homestead. It is happily written and very suitable to the occasion which called it forth.

Last Night's Concert.—The concert in the Fifteenth Ward new meeting-house last night was a thorough success financially and artistically. Notwithstanding the inclement weather, the commodious house was well filled, and every thing went off beautifully. The entertainment was all that could be desired, vocally and instrumentally, but we lack space to make extended mention of everything. Among the most pleasing features was the orchestral selections by Messrs. Beasley, Olive, Smith, Castleton and Gilles. Jos. R. Morgan marked the conductor's baton with marked efficiency, and the piano accompaniment, by H. E. Gilles were very good. Among those present were Apostle Joseph F. Smith, Elders A. M. Cannon, Jos. E. Taylor, C. W. Penrose and H. W. Naisbitt, besides the authorities and other prominent Elders of the Fifteenth Ward. At the close of the concert, Bishop Pollard announced that the first meeting in the new building would be held Sunday evening, at which time Elders Joseph F. Smith and Chas. W. Penrose would address the congregation.
