## **ARIZONA CANALS.**

HOW THE "MORMONS" MAKE THE DESERT BLOSSOM.  
 Bishop F. A. Hammond, of Huntsville, Weber County, who returned on Saturday morning via the D. & R. G., from his trip through Arizona, Colorado, New Mexico, and a portion of Old Mexico, on which he has been traveling constantly since the 16th of last December, brings with him some interesting statistics in regard to the canals made or purchased by the Latter-day Saints in the arid valley.  
 The Smithville Canal, made by the "Mormons" in 1853, contains about twelve square feet of water and covers about 2,000 acres of land. It cost over \$5,000, and is six miles long. The land it waters is owned by 30 or 35 individuals, averaging 57 acres to the man.  
 The Canyon Canal is on the opposite side of the river and is owned by 20 men. It covers 2,000 acres, carries 12 square feet of water and is 7 miles in extent. Acres to the man, 100. This canal was bought by the Saints at a cost of \$5,000.  
 The Central is a canal about 12 miles in length, including an extension made to cover Smithville. It was originally a purchase and has cost \$7,000. It is owned by about 100 men and covers 4,000 acres, averaging 40 acres to the individual. It contains about 15 square feet of water.  
 The Graceland ditch, on the north side of the river from the Central, was bought by our people. It is about four miles long, contains eight square feet of water and supplies 1,000 acres, divided among the owners of the ditch, 10 in number. It cost \$5,000.  
 The Kaysville ditch is on the south side of the Gila River, but north and west of Smithville. It was made by our people, is four miles long, has eight square feet of water, and covers over 500 acres. It is owned by eleven men, averaging about fifty acres apiece. It was constructed at a cost of \$2,000.  
 The Patterson canal is also on the south side of the Gila, and west of Smithville. It was bought by the Saints. It is four miles long, carries ten square feet of water, and covers 100 acres of land. It cost \$3,000, and is owned by twelve men.  
 The Curtis canal, on the north side, is five miles long, contains ten square feet of water, covers 2,000 acres, and cost \$4,000. It was purchased by our people and is owned by twelve men.  
 The Kempton ditch is on the north side of the river, a little below the Curtis canal. It was made by our people at a cost of \$1,500. It is three miles long and waters 300 acres, having eight square feet of water. It is the property of six men, each of whom owns about 50 acres.  
 The Bryce Canal is on the north side of the Gila, and north of Smithville. It was made by our people at a cost of \$3,000 and covers 1,000 acres. It carries eight square feet of water. It is four miles in length and is owned by five men.

Death of Henry A. Shaw.—The following appears in the Utah Journal concerning Elder Henry A. Shaw, a very excellent and faithful member of the Church, who died at Paradise, Cache County, Utah, of dropsy, on January 20th, 1884, being aged 51 years, 10 months and 20 days:

"Deceased was born at Shrewsbury, England, March 6, 1832, was baptized into the Church of Jesus Christ of Latter-day Saints at Shrewsbury, Nov. 22, 1850, by Elder Chas. D. Evans, confirmed Nov. 29th, under the hands of Apostles F. D. Richards, Jos. W. Young and Chas. D. Evans; ordained an Elder and sent forth to preach the gospel.

He labored in the Shropshire, Birmingham, Staffordshire, Warwickshire and Derby Conferences, and was appointed president of the Utah Territory Conference; emigrated to Utah in the spring of 1851; taught school in Centerville and Riverton; in the year 1853 moved to Paradise, taught school for 17 years. One term at Hyrum and three terms at Midville. Appointed postmaster of the year 1875, which office he retained till the day of his death. Elected judge of the peace in 1878 and retained till 1882. Was a member of the High Priests' Quorum, and Second Counselor to Bishop Orson Smith for seven years.

The funeral services were held at Paradise on Monday. The church was filled to its utmost capacity. Appropriate addresses were delivered by Elders Henry W. Nye, James D. James, Salt Lake City; Elder James Bishop, Henry C. Jackson, and James D. Evans, of Marsden; Ephraim Geo. O. Pitkin, Wm. H. Maughan, and Orson Smith. Counselor James Unsworth pronounced the benediction. Fifty-three conveyances followed the remains to their last resting place. Bro. Shaw lived and died a faithful Latter-day Saint. Each speaker gave the faithfulness of the deceased. In a conversation with Brother Shaw a short time before his demise, he said: "For nearly four months I have been waiting to go hence. I am not afraid to die. I have given my youth, my manhood, my whole life to the service of God and His people. I feel that He will soon take me to Himself!"
