A JUST CAUSE.
The relations and peculiar position of the country is practically unanimous on the question of the justice of the war now on, and the determination of the people is not shared by all who are not misled by prejudice. THE WORK BEHIND US.
There appears to be a difference of opinion as to whether the President of the United States has a right to send the National Guard outside the country. Congress has the power to provide for calling forth the militia to execute the laws of the Union, suppress insurrections and repel invasion. The cases in which the services of the militia can be required are specified in Article XVI of the Revised Statutes as follows:
"Sec. 1142. Whenever the United States is invaded, or any insurrection or rebellion breaks out within the United States, or any insurrection or rebellion against the authority of the United States exists, the President may call forth such number of the militia of the State as may be necessary to execute the laws of the United States, to suppress such insurrection or rebellion, and to restore such authority to the United States as may be necessary."
