LOCAL AND OTHER MATTERS.

FROM TUESDAY'S DAILY, MAY 11.

The Arbitrators Decide.—The committee of arbitration, Messrs. A. Gardner, R. Miller and I. M. Stewart, to whom was referred the matter of the right of way for the Jordan and Salt Lake City Canal through land belonging to Mr. Angus M. Cannon, in the southern part of this county, have decided that Mr. Cannon should receive from the city the sum of \$1,100, as reimbursement for the land to be so used, and for the damage he sustained by the appropriation of a projected mill race, located along the line pursued by the canal. The matter will be presented for the approval of the City Council this evening.

Liverpool Notes.—From an interesting letter to Elder Joseph Bull, from Elder Francis Cope, at the Liverpool Office, dated the 21st ult., we glean the following:

Matters were progressing favorably in the office at Islington. A goodly number of tracts had been issued since Christmas, the latest entitled "The Latter-day Prophet," by Elder John Nicholson.

The next company of Saints would leave Liverpool on June 5th, a much larger one than the last. There was an immense emigration from Europe at present. Every ship went out loaded.

The weather was fine and the country beginning to look nice and beautiful. Considerable out-door preaching had been done already this season, with an immense distribution of tracts, which it was expected would result in the conversion of many souls to the truth.

Mutual Aid Society.—A Mutual Aid Society was organized by the employees of Z. C. M. I. Shoe Factory and Tannery, at a meeting held by them for that purpose, on Saturday evening, May 8, 1880.

The officers and directors are: Wm. H. Rowe, President; D. M. McAllister, Vice-President; A. Frewin, Secretary and Treasurer; W. Hayes, W. Bates, J. Poulton and W. Pierce, Directors.

None but employees of Z. C. M. I. Shoe Factory or Tannery, who are over fourteen years of age, will be admitted to full fellowship in the Society, but it is provided that any person, who desires to assist in its laudable purposes, may be admitted as an Honorary Member on payment without further assessment of ten dollars or upwards. Honorary members are not entitled to receive any benefits from the Society, they may, however attend meetings and vote on all business matters, and are eligible for election as officers.

The members entitled to receive aid are divided into four classes, named respectively A, B, C, and D; their contributions and benefits are apportioned as follows:

The amounts apportioned for aid may be increased hereafter if the financial condition of the society will admit of it.

When the funds on hand are sufficient to afford such outlay, members who lose a wife or husband by death shall receive the sum of \$30, and \$15 in case of the death of a minor child.

Meetings are to be held on the first Saturday of each month, at which a variety of exercises will be introduced for the benefit and enjoyment of the members, including singing, lectures, etc. Messrs. Poulton, Beesley and Romeril are

appointed a committee to arrange programmes for these meetings.

Zion's Musical.—The first annual meeting of the members of Zion's Musical Society was held at the Council House last evening. There was a large attendance, indicating a lively interest, which is very gratifying to the officers and others who are laboring for and desiring its success.

After a short practice on a new comic glee, the meeting proceeded to the transaction of business. Vice-President D. O. Calder presided, and stated that other duties prevented the attendance of President Taylor, who was heartily interested in the progress of the Society. The Secretary read a statement of the present standing of the Society, showing that in all respects it is of a satisfactory character. The Constitution and By-Laws were read and amended in a few particulars. The most important change was that relating to the number of Directors, which it was deemed advisable to reduce from twenty-five to eleven. The following Board was elected for the ensuing year:

John Taylor, President; D. O. Calder, Vice-President; D. M. McAllister, Secretary; A. Parsons, Assistant Secretary; J. Kirkman, Treasurer; H. Gardner, Librarian; C. J. Thomas, A. C. Smyth, J. R. Morgan, W. H. Foster and E. T. Woolley, Directors.

On motion, a hearty vote of thanks was tendered to Conductor Thomas, in recognition of his invaluable services.

Remarks were made by Vice-President Calder, Mrs. Dr. Ferguson, A. Parsons and others, encouraging the members to take advantage of the means provided by the Society, and continue their efforts to improve the musical talent they possess.

Prof. C. J. Thomas was re-appointed Conductor, with Professors A. C. Smyth and E. Beesley, assistants. H. E. Giles was appointed accompanist and Mrs. Dr. Ferguson assistant.

At the directors meeting held subsequent to the general meeting, arrangements were made for giving an entertainment at an early date, for the object of procuring necessary funds with which to assist in carrying out the purposes of the Society.

FROM WEDNESDAY'S DAILY, MAY 12.

Sentenced.—Ammon P. Pitkin, of Millville, the incestuous parent, has been sentenced to twenty years in the Utah Penitentiary.

On the Ocean.—President A. O. Smoot and party, who left here on the 3rd inst. for the Sandwich Islands, arrived in San Francisco on the night of the 5th, having made the trip to the Coast in 40 hours. They set sail on the 8th, per steamer *New York*, and are now on the placid bosom of the Pacific.

More of Them.—The *Enquirer* informs us that James C. Blansett and Orson Kelsey were brought from Fairview, Sanpete County, on Wednesday night, by Sheriff Turner, and lodged in the Utah County jail. These men are charged on the United States Commissioner's warrant with having received stolen property, knowing it to have been stolen, and are evidently associated with the gang which the Sheriff succeeded in breaking up several weeks ago.

Returned Missionaries.—We had a call this morning from Elders John Morgan, Henry W. Barnett and Matthias Cowley, who returned from the Southern States last evening. Elder Barnett is a resident of Payson and will leave for his home in the morning. Elders Morgan and Cowley are well known as members of this community. Elder Alexander Spence, of Wellsville, came home with the party, but remained at Ogden and took the train for his home in Cache Valley this morning. Brothers Barnett and Cowley left here together two years and nearly three months ago, have labored jointly most of the time, nearly all of it in the Virginia Conference, and were the means of bringing about 120 persons into the Church. Brother Spence labored effectively in the North Carolina

Conference, about 18 months. A company of about 80 of these brethren's converts have emigrated to Colorado. Elder Morgan, as is well known, has performed a good work as the efficient and energetic President of the Southern States mission. They all return in good health and we heartily welcome them home.
