

# TELEGRAPHIC. CHICAGO'S DISPLAY.

The Fair City Transformed into a  
Varied Fairyland.

DEBT WIPE OUT WITH A CHECK.

A Great Number of Casualties Es-  
caped.—Other Items of  
Interest.

CHICAGO, Oct. 9.—The Exposition was transferred into fairyland tonight. Bright lights flashed from every nook and cranny in the buildings, search lights cut wide swathes in the sky, multi-colored robed lanterns, showers of fire rained about the grand basin and on the lakefront. Through it all flamed, representing Chicago's progress, were bonfires. It was the grand climax of the Chicago tidal day of the Fair.

The fests were marvels of beauty. First was the "Garden of Music," at her feet clustered a cluster of over-flowing whisks singing out on the night air. Next, "Chicago," represented by Miss Elizabeth Flynn, who appeared as a typical Chicago girl. On the same float with the fair-haired representative of the city were the "Four Liberties," "Music," "Art," "Literature."

Chicago as a trading post in 1812 was represented on the third float by a reproduction of the Indian of the Fort Dearborn.

Michigan's famous firs, the figures of Grant, Lincoln, Douglass and Bishop Yale and Chicago offered their arms to Lincoln who was on the fourth float.

The fifth was the "Angel of Peace," while Minnie Pendleton's typical of the effects of the big fire, was represented by the sixth float. At the rear of the car Chicago was seen rising from the ashes.

The seventh float was emblematic of Commerce.

The nineteenth float in the procession represented Columbus at the court of Isabella and brought up the rear.

The eighth float of the brilliant pageant was the Chicago Museum, followed by a band of a thousand pieces. The processional went its way through all the principal avenues of the White City, and crowds occupied every inch of ground and every foot of space on the sides.

The fireworks which followed were probably the finest ever seen. No expense was spared and the magnificence of the display was beyond compare. It was shot from every corner of the White City, and filled occupied every inch of ground and every foot of space on the sides.
