

## THE TABERNACLE CHOIR.

Professor Stephen's Report—Achievements of the Past—Improvements for the Future.

Thinking it would be of interest and but a just consideration to the public, who have so kindly shielded us, to receive a report of our doings for the two years of our existence as a reorganized choir, I have prepared a condensed but complete account of the same, trusting to the kindness of the press to give it publicity.

During the two years I have had charge of this musical organization, our hundred voices have been added to its membership, making a present total of 500 voices. The average attendance has been a little over 200 for the past year. In addition to the regular choir a Juvenile choir numbering 100 voices has been organized, including a fine band of fifty boys, in charge of Mr. C. H. Barnes.

The adult choir has held about 150 rehearsals and sung at about 120 services or meetings. The juvenile choir has held about sixty rehearsals.

The design of the latter is to train up members for the future adult choir, aiming to develop the love of music and the love of the Lord in the hearts of giving their children, brothers or sisters a musical training free of expense to them, & possible.

We have taken part in numerous services, including the annual meeting of the Union, our Jointly with the ward choir, two with the Choral Society and Granite's band; one with the Men's and Women's choir and two by ourselves.

THE SANITARY CENSUS.

Inspection of Premises to Commence Some Time This Week.

Dr. Beatty, of the city board of health, said this morning that the taking of the sanitary census would commence sometime during the present week, probably within the next day or two.

Two inspectors will be appointed by the health committee, the exec. president, and it is expected that the sanitary census will be conducted with in a period of time. Dr. Beatty said that every resident in the city will be visited and the condition thereof reported to the board for act.

"We must prepare for a possible epidemic next season," said Dr. Beatty. "Certain laws will be made in a clean city if the council will only stand by the course we have outlined."

It is thought that there will be a ward division in the matter of conducting the sanitary census, and that it will be made by the board when it comes up before the council.

YESTERDAY'S FIRES.

The Third South Street Blaze at One Time Threatened to be Very Serious.

About half past eight o'clock last night a fire was discovered in the building just east of the St. Elmo hotel on Third south street. An alarm was quickly sounded and the department rushed out in good shape and was soon on the ground, and after three minutes work had the fire practically extinguished.

In the building was located Albert Berg's jewelry store, which was damaged to the amount of \$800, issued for \$800. It is understood that the fire was caused by a short circuit, and covered or obscured the hot prospect of a short, but as a consequence, slight reading, effective char, starting, vapor, conduct, harmony and composition, and pipe organ playing.
