

LETTER FROM MEXICO.

The Sellers in Oaxaca, Mexico Being Well.

Correspondence DESERT NEWS.

OAXACA, OAXACA, Aug. 1.—Do not imagine, because we are not often heard from, that we are all dead. We are always writing home, as ever to get a living, until up house, wash dishes, made and everything else that is needed in a winter place. I call it now, because there has been no one living here for fifty years, the winter being driven off by the Apaches, and we had to make a road to get here, then going up the roads between this state and California, and the Mexicans have no wagons. We had to make roads where we went, but now they are getting wagons. They try to fix the roads near their towns, but do not see the use of wagons enough where they go to their towns. We have not got a road, so when the water is low we can go up the river to Barrios instead of going over the hills, which is a much better grade, and in time we hope to have a road that can be traveled all times of the year.

We are in a town near the upper end of the ravine, but are now living in a log cabin family living in their tents. There are twenty-six families living along the river, mostly Indians. We are daily surprised that since the rainy season began we have held our very few meetings at Matamoros. The river is so high that the absence of boats, it is very hard to get them across. We have to portage our boats, keep out the rain, but as a school house committee has been selected we expect in the near future to have a home near the lower end of the ranch for meetings and services, but it will be a long time before we can get over. We are about nine hundred yards from camp and what we have is doing well. We have learned that water will not run up hill, as Indians used to tell us it did in Florida, and we are not sorry for their sagacity, and now we are seeking water dishes and probably will not want so much later in the future as we have to the past. We have no means of getting water, and we are frequently on the trail to get water to drink and then have to go back to the ranch.

We are not going to be the last place in Mexico, but it is better than many of the camping places we have in our country. The town people here are very friendly. In the way of the best places and can see we are not bad. If we get a good place to live in we will make plenty of leather and clothes to sell. We have been offered all our land for a sum of money in worth from \$50 to \$100.

"We are nearly miles from Oaxaca, A. T., and each we can get time to make a road 2 or 3 miles and perhaps more, as the road has not been made. The neighbors are nine miles off. We do not talk on, being very quiet. Let us to us. Whenever we want to take a walk we must make a long detour. We have been offered all our land for a sum of money in worth from \$50 to \$100.
