unnecessary delay, and that he will use his utmost ability to prevent any interference whatever therewith by

any person whosoever."

The instructions of the commission 'provide that the election returns may be forwarded to the commission by mail or other safe conveyance, instead of by a qualified voter as provided by the foregoing section of the law. We think the statute should be complied with in this particular. The same section this particular. of the statute makes the election returns cousist of the election list and requires that they should be forwarded, securely sealed. In addition to these, the commission has required an abstract to be made, and in many instances the lists have been put into the ballot box justead of being sent in the envelope. many of the judges of election have heretofore misunderstood what constitutes a legal, return and have sealed the list up in the ballot box, it seems desirable that their attention be called to the matter in order that they may strictly comply with the law. The following, if issued by the commission, would seem to

cover the ground:

The registry list, the poll list, and
the two tally lists and the abstract should each and all be duly certified by the judges of election, and these lists, with the abstract, should be forwarded to the commission at Salt Lake City, in an envelope securely sealed. No list should be put in the

ballot box.

We respectfully request that the foregoing, or something of similar import, be issued by the commission and sent to the judges as soon as

practicable.

The representatives of the Peopple's party at Beaver say that all the judges of election appointed for that precinct are all Liberals and request that either C. H. Tanner, Benjamin Bennett, W. H. Baker, W. H. Farnsworth, R. W. Stoney, or Andrew Morris be substituted for H. Emerson as one of said judges. The same complaint is made from Richfield preciuct, Sevier county, that all the election judges are Liberals and it is requested that a representative member of the People's Party be substituted for one of said judges. Names will be submitted hereafter. The representamitted nereafter. The representa-tives of the People's Party at Rich County say that Thomas Wilson of Randolph, heretofore a judge of election in that precinct, and also a candidate last election, is unfair, and ask the appointment of John Snowball of Randolph, also J. H. Neville for Woodruff precinct.

The precinct of Stead was created in Davis County this fall after the September revision of the registry lists. As there is no poll provided for in the new precinct and no registry list for that preciuct, the voters residing therein have been advised by the county registration officer that they can vote at the several polling places where they have been accustomed to vote heretofore,

The electors ask your opinion on this subject, as they desire to cast their votes, and yet conform to the law.

THE COMMISSIONERS' REPLY.

To this the commissioners yesterday sent the following reply:

S. Richards Esq., Chairman People's Territorial Committee;

Sir-In reply to your communication this day received, after due consideration it is the opinion of the commission that it is neither advisable nor practicable to have the election returns of the several precincts returned by a special messenger, and it therefore declines to make a change in the manner of returning the same. Upon the question of instructing the judges of election to certify all the lists required by law and the instructions, and forwarding them to the Commission duly sealed, the Commissiou deems such request a proper one and will instruct the judges of election accordingly. regard to the complaints from Beaver precinct and Richfield precinct, the Commission has caused inquiry to be made of its registration officers, and, if found that the state of affairs exist complained of, will take steps to have both parties represented on the election boards of such precincts. In the case of Thomas Wilson, of Randolph precinct, and Joseph Neville, of Woodruff precinct, the commission deem the charges too indefinite for the basis of any action. In regard to the new precinct of Stead, in Davis County, the commission has appointed a deputy registration officer for that preciuct and instructed him to at once transfer from the former precinct registry lists the names of all registered voters of the territory embraced in the new precinct of Stead, and to make the necessary lists, designate a convenient polling place and give due notice of the Very respectfully, ELIJAH SELLS, Secretary. same.

Christianity advocates faith in God as the Father of the spirits of all men; the Crestor and Supreme Ruler of the universe, and as such He is entitled to our highest spiritual devotion.

Tribune "Liberalism" emphatically declares that oran's "first, highest and holiest obligations" are to his country; thus ignoring entirely any higher obligations than those of man to his fellow-man. Infidelity in its most subtle and unmitigated form is thus announced as the platform of "Liberalism," and is the foundation of its determined opposition to the Christian virtues.
