elation, expressing an earnest desire for a family dormitory, where husbands and wives, brothers and sisters, may stay economically and comfortably under the same roof, during their visit to the Colombian Exposition, was the incentive that led to the incorporation and organization of the enterprise to which your attention is called.

The promoters know that there are numberless families in every state and territory who desire to visit Chicago during the Fair, but who feel that their hopes cannot be realized because their moderate means will not permit the exmoderate means will not permit the ex-orbitant prices which usually prevail at such times. Not only do slender purses stand in the way of a realization of their desires, but there are also the dangers of a great city (erowded with all sorts and conditions of people), that cannot be overlocked, when the question arises: Can we go to see the wonders of the world gathered at Chicago without too great a sacrifice of money, and feel at home there? homethere?

It is believed that the dormitory plan. as outlined below, answers these ques-Lions affirmatively. Question. What does a share of stock

cost and what are the privileges granted?

Answer. A share of stock costs \$10, and entitles the holder to twenty days' occupancy of a room. Stock certificates will be issued containing twenty coupons, each good for one days' occupancy if de-tached at the dormitory office. This does not include meals. A dinng room will be directly connected with the dormitory building, where regular meals and lunchcons will be supplied at reasonable prices.

Question. Are the rooms petitioned off,

Question. How high are the buildings? Answer. Unly two stories. I few sleeping rooms on the ground floor reserved for elderly ladies.

Question. Do all rooms have outside windows?

Answer. Yes, every room in the build-ing will have outside windows, with tran-soms over the hall doors, instring good light and circulation. Each building will be in the form of a hollow square, enclos-n g a spacious court, where flowers and i nes will be planted in profusion.

Question. How are the buildings lighted ?

Answer. By electricity.

Question. How heated? Answer. By large, old-fashioned fire-

places in the parlors. Question. Can stockholders receive

friends? Answer. Yes, the large parlors and

reading rooms will be always open for the use and pleasure of stockholders. Question. If there should be a failure

to meet obligations, are the stockholders liable?

Answer. No. The stock holders are not liable for any of the obligations of the association, neither are they entitled to any emolument or dividend which may accrue to The cost of their stock is returned to it. them by their occupancy of rooms in the dormitory building, or by the occupancy thereof by persons to whom their stock is transforred. When shares are pur-chased, it is requested that the purchasers designate the dates during which they desire apartments reserved for them.

Answer. Corner Seventy-fifth street Answer. Corner Seventy-fifth street and Yates avenue, seven blocks from the World's Fair gates and Sixty-seventh street. Only one block from Illinois Central Railway station, Windsor Park, and only four blocks from the Great Central Depot of the World's Fair.

Question. What transportation from dormitory to the World's Fair? Answer. Electric cars pass the door; five minutes ride to World's Fair; fivecent fee. Stone sidewalks the entire way to the Fair gates.

Question. Can a physician be summoned?

Answer. Yes, those who may need medical service will be attended by a resident house-physician at moderate COST

For the purpose of protecting the oc-cupants of the dormitory building from loss or damage by fire, no fires or oll lamps will be permitted in rooms. Great attention will be paid to proper sewerage and other sanitary measures.

Special care will be given to the comfort of elderly people, meeting them at the depot, providing guides at small cost and giving all desired information A south porch will be built where the

elderly people may congregate when the sun goes down on a wearisome day, and talk in the twilight of the wonderful sights they have seen, while the children claim the playground, Parties who desire to take advantage of

## GRAVITY SEWER PLANS.

City Engineer Dotemus presented. City Engineer Dotemus presented, each member at the City Council with a blue print map of the route of the proposed gravity sewer. From the proposed sewage farm several mites. uorth of the city its course is traced as tollowe: it enters the city from the county road at Fourth West, which it follows to Ninth North, to Third West. to Seventh North to Second West, to Third North back to Inira West, to First Noith to Fourth West, to First South to Third West, to Second South, to Second West, to Third South, to First West to Fourth South, to West femple, to Firth South, to State, to Sixth South, to Scate, to Seventh South, to Third East, to Eighth South to Fourth East, to Ninth South. By this mute every sewer now in operation or in contemplation in the north, east and southern portions of the city con be connected with the system and in time the useds of the western portion can be attended to to the same manuer.
