in that branch. There are two or three
Indian scouts enroled in the department
of the Indians. They will be
retained for some time and afterwards
one officer who commanded the Indians
says they were the best behaved
company he had ever seen.

Two people prefer prison life to the
freedom enjoyed by persons who have
never been compelled to do the striped
garb, says the *Utah Journal*, and
John N. Nels, who has the past seven months
been incarcerated in the penitentiary
for a burglary committed in Kamas
county, now has an
empty prison, and although his
sentence is not yet completed, he
will, under the rules of the institution,
serve him one month's commutation.
Yesterday the eleven
months expired and Nels, informed
him he was to liberty as
soon as he was released. The prison
gate was open, the prison walls were
of his preference to being turned
out in a cold world. This Western
boy Nels was sorry for him, but
himself was up, and he would be required
to leave the house in which he had
lived for so long a time. Then Nels adopted new tactics.
He raised the point that he did not have to
accept the month's release on his sentence.
He did not, but he preferred to bring
up the question of his release. He
pleaded his case before the warden
and the governor, and was granted
a reprieve, and was released with
the expiration of the full twelve
months. This raised an entirely new
and novel question, and Sheriff Warren
said Nels was disappointed in his
new home. Warren said Nels
was to be allowed to go to the
army of the West, and he did not
have to accept the month's release
on his sentence. This was
nearly a week ago.
