

## Kaiser Criticizes Russian Army.

One That Fought at Mukden Had Become Enervated by Immorality and Drunkenness.

THAT EXPLAINS ITS DEFEAT.

Circumstances Might Arise that Would Put on Germany Task of Opposing Yellow Danger.

Berlin, May 11.—Emperor William, addressing the higher officers during a review of troops at Strassburg today, said, according to the Strassburg Reiter Zeitung, whose statements may be taken with some reserve:

"The Russian army, which fought at Mukden had become enervated by immorality and drunkenness. Only in this way can its defeat at Mukden be explained. As Russia has shown weakness in the presence of the yellow danger, circumstances might arise which would place upon Germany the task of opposing this danger. Officers and men must spend their time well so that they shall not fall into immorality and intemperance."

The emperor's speech at the swearing in of naval recruits at Wilhelmshaven March 9, in which, according to the brief report published at the time he accused the Japanese as a luminous example of patriotism and soldierly fidelity and of which the Evangelische Kirchen Zeitung as explained to the Berlin Neueste Nachrichten by a person present was not intended to be made public. He added that it was also a confidential. The officiating clergymen had spoken of the courage of the Japanese in such a way as to permit the recruits to infer that it made little difference in war whether the soldier was a Christian or a heathen. The emperor thereupon spontaneously undertook to correct this impression.

## FRANCE GIVES ASSURANCE OF HER NEUTRALITY

Paris, May 11.—A semi-official statement from high sources was published today giving France's position in reply to Japan's charges of breach of neutrality. One of the headings is: "Japan has done in the Philippines and Dutch East Indies the same as she accuses France of doing in Indo-China." The conclusions are set forth as being:

"First, the French neutrality regulations were not established for the purpose of war but existed previously without protest from Japan."

"Second, France has exercised her sovereignty to fulfill the regulations not only to the full letter, but has also adopted special measures to maintain absolute impartiality."

"Third, the only direct purchases of coal by the Russians were at Algiers, where the quantity was insignificant. The main stock of coal was purchased in Germany and England without protest."

"Fourth, any advantages which the Russian Second Pacific Squadron obtained by anchoring off the French coast were equally open to the Japanese if they had taken the offensive instead of awaiting the Russians."

Tokyo, May 12, 10 a. m.—France's latest assurance of neutrality ease the situation somewhat but do not remove the deep-rooted popular resentment against her.

The press urges the government to maintain a strong attitude toward France and demand explanations, saying that it is necessary that France explain events between May 3 and May 9.

## RUSSIANS AND JAPANESE BOTH CLAIM SUCCESS.

St. Petersburg, May 11.—Gen. Linovitch, in a dispatch to Emperor Nicholas dated May 9, says:

"Our advanced posts along the line from Polyuzscoe to Shihouza were attacked by the enemy's cavalry on May 7. The Japanese were repulsed. They renewed the attack May 8, but were again unsuccessful."

"On May 9 our cavalry advanced in the direction of the Shakhety mines which were occupied by Japanese, who, in the face of our artillery fire and a turning movement westward of the mines, were obliged to retire toward the village of Shihouza, from which they subsequently were dispersed, retreating to the village of Madipa."

Tokyo, May 12.—The following telegram from army headquarters in Manchuria was officially given out today:

"On the morning of May 9 the enemy, consisting of two regiments of infantry, five companies of cavalry and one battery of artillery made an attack in the vicinity of Yingcheng in the direction of Nanshanhongzi, which is fifteen miles east of Yingcheng."

"At 2 o'clock in the afternoon the enemy made a resolute attack. Under the cover of the artillery the in-

## HOOCH'S TRIAL.

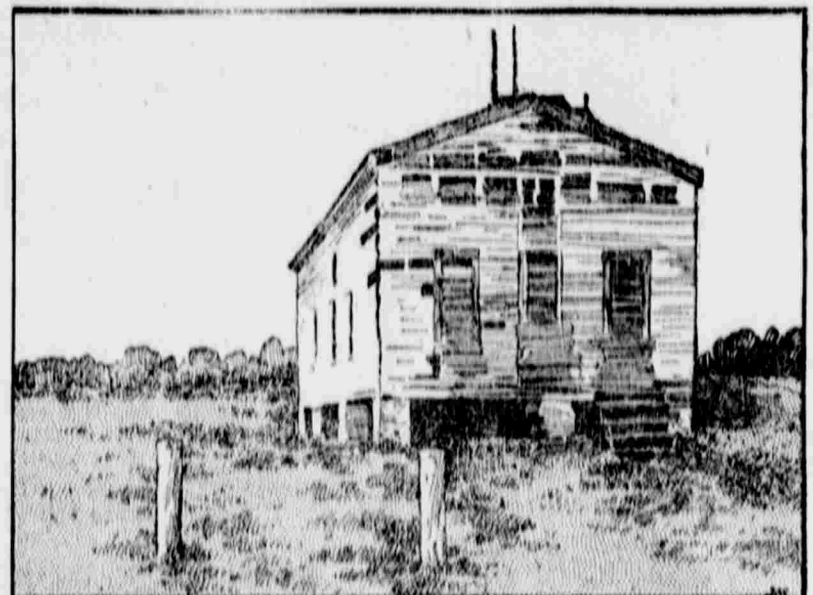
Testimony of a Sensational Character Brought Out.

Dr. Ludwig Hebbelen told of pathological studies of the organs of the dead woman and declared he found no condition of nephritis, such as would cause death.

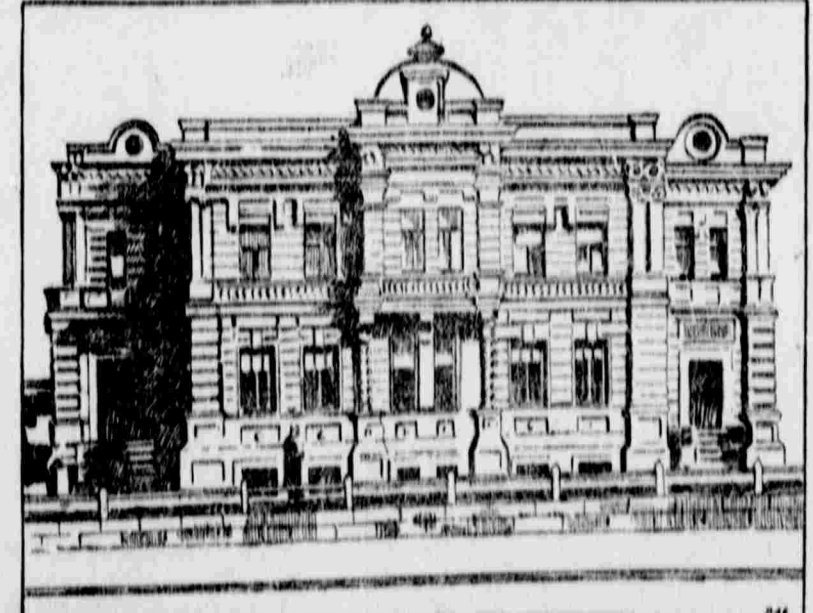

## WHERE HENRY M. STANLEY ONCE TAUGHT.



The cut shows the old schoolhouse at Fort Gibson, Indian Territory, in which the late Henry M. Stanley, the great African explorer, once lectured as a pedagogue. It was once the old garrison church, but was subsequently converted into a schoolhouse. Fort Gibson, the oldest town in the territory, has been the temporary residence of many notable persons. General Hazen and his bride, now the wife of Admiral Dewey; General Zachary Taylor, who was afterward president; Jefferson Davis, General Sam Houston and General Arbuckle were all citizens of the old town, and Washington Irving wrote his "Tales of a Traveller" in a tent on Garrison hill. The school taught by Stanley was a subscription affair patronized by the garrison children.

## THE RUSSO-CHINESE BANK AT HARBIN, MANCHURIA.



The cut illustrates one of the sources of the power which Russia has wielded in Manchuria, the great banking concern which has been such a prominent factor in the Manchurian occupation. Harbin has been the principal center of supply for the Russian forces ever since the outbreak of the war, and it is the scene of great activity. It has been called "the Chicago of the east," and the term is not unwarranted. It is situated on a level plain about 200 miles north-east of Mukden. At present it is full to overflowing of the Russian wounded, and every building that can be obtained is converted into a hospital.

Frederick O. Collins, druggist, of New York, Hooch declared when arrested that the poison found in his fountain, "arsenic," was bought at Collins' store. The druggist came to Chicago, armed with the register book the laws of New York require druggists to keep, in which to record the sale of poisons. This book does not show that arsenic was ever sold to Hooch on the date he mentioned, or to any other person answering his description.

The afternoon session was occupied by the examination of Dr. Hebbelen, who assisted at the last examination of the body of Mrs. Welcker-Hooch. He gave it as his opinion that death had been caused by arsenical poisoning. His cross-examination was long and tedious, but Dr. Hebbelen held firmly to this declaration.

## PRESIDENT'S JOURNEY ENDS

Reaches Washington After His Trip of Six Thousand Miles.

Washington, May 11.—President Roosevelt reached home tonight at midnight from his western trip, which he regards as one of the most enjoyable journeys he has taken since he has been president. He traveled about 6,000 miles and passed through 12 states and three territories—Maryland, Pennsylvania, Ohio, Kentucky, Indiana, Illinois, Missouri, Kansas, Indian Territory, Texas, Oklahoma, New Mexico, Colorado, Nebraska and Iowa. Every state and territory in the United States except Florida and Arkansas has been visited by President Roosevelt since he has become president, and it is his intention to accept the hospitality of these states before his term is finished. It is probable he will make a tour of the south before the convening of Congress in the fall of this year.

The demonstrations at every point where the president spoke are said by the official members of the party to have been the heartiest that have ever been accorded him on any trip.

The president left the train immediately after it rolled into the station. He shook hands with the train employees, newspaper men and others who greeted him. Then with Dr. Lambert he stepped into his carriage and was driven to the White House.

## ARMOUR CAR LINES.

Testimony of Complainants in Investigation Completed.

Chicago, May 11.—Testimony of the complainants in the investigation of the affairs of the Armour car lines by the interstate commerce commission was concluded today and, as the respondents stated that they had nothing to say, the commission announced that briefs should be filed by the complainants within 15 days and by the respondents within 20 days. The arguments will be made before the commission in Washington.

Several witnesses were heard by the commission today, and to compare the charges of the Northern Pacific lines for icing with those of the Armour lines. H. P. Ober, manager of the perishable freight traffic of the Northern Pacific, was put on the stand and examined by R. S. Fowell of the Western Fruit Jobbers' association. Mr. Ober testified that the cost to his company for icing averaged from \$1.10 to \$1.75. He declared that the average charge for icing cars and numerous railings was \$25 per car on shipments of fruit from western points to St. Paul when the company's own cars were used.

When the Armour cars were used, however, he said, a charge of \$25 was made, and the extra \$10 went to the Armour people in addition to the rental charges made by the Armour lines. In concluding his testimony, Mr. Ober said that his company only charged shippers of fruit the actual cost for the icing of the cars.

## A BAD MAN.

John Hewitt Kills Wife, Shoots Her Brother and Sister, Suicides.

Valdosta, Ga., May 11.—John Hewitt, a white man of Adel, shot and killed his wife today, shot her sister and brother, wounding them slightly, and then surrounded by a posse of citizens, shot and killed himself. Hewitt's mind had been affected by ill-health.
