It is the intention of the proprietors to enlarge the mill soon and put in six or eight more pans. Mining matters generally are looking up and everything portends better times coming.

MUSICAL FESTIVALS .-- The great festival at Cincinnati is succeeded by a smaller one at Indianapolis, which as the telegraph reports, opened on Tuesday evening, 20th, with success, under the conductor ship of Mr. J. S. Black, formerly a music teacher in Chicago. It is only an echo of the Cincinnati one, both chorus and orchestra being weak, but it has the effective services of Mrs. H. M. Smith and Messrs. Winch and Whitney as soloists, in the performances of Handel's "Messiah," Haydon's "Seasons," and Mendelsshon's "Elijah," and is a step in the right direction. It shows that the great succes-es of 1873 and 1875 in Cincinuati are beginning to take root elsewhere, and are doing good work. Meanwhile, as we have once before asked, what will Chicago do? Theodore Thomas stands ready to give a festival here in 1876 or 1877. We may not be able to accomplish all that Cincinnati has done, first time trying, but we believe it can be done in time. 
