Senate.

WASHINGTON, March 2.—The Senate reassembled as in continuation of yesterday's session at ten o'clock this morning.

A message from the House announcing non-concurrence in the Senate amendment to the navy appropriation bill, was presented and a conference ordered. Harkness and Beck were appointed conferees. A few moments later the Senate closed the legislative day Wednesday by adjournment, and opened the last legislative day of the Forty-ninth Congress, when prayer was offered by the Chaplain. The Senate then proceeded to the consideration of the Judiciary, executive and judicial appropriation bill, voting on the amendments recommended by the committee on appropriations. The bill was passed by a vote of 74 yeas and 16 nays.
