

# CHICAGO WILL NOT COMPETE

Won't Send Delegation to Washington to Secure National Republican Convention.

BUT WILL EXTEND INVITATION.

City Council Adopts a Resolution Directed to National Committee—Kansas City Making Fight.

Chicago, Dec. 2.—Chicago will not send a delegation to Washington to secure the national convention of the Republican party, but will extend an invitation to the Hamilton club committee, selected to obtain the convention, was disbanded yesterday after a conference. It was decided that Chicago should not enter into any competition with other cities to secure the convention in the matter of a financial consideration, but instead, through Congressman Frank O. Lowden, should invite the national committee to fix Chicago as the place for the next session. In the invitation is to go a guarantee that Chicago's hospitality will include a first class convention hall, well equipped.

All arrangements had been completed for carrying the Chicago delegation to the capital in style. A special car had been provided over the Pennsylvania system, but this order has been cancelled.

A delegation, 25 strong, from Kansas City passed through the city yesterday on the way to Washington to land the convention. It is said they had in their possession a certified check for \$75,000. The Chicago city council last night adopted a resolution inviting the national committee to send the convention to Chicago.

## A PERSISTENT STOWAWAY.

Russian Lad Has Made Seven Transatlantic Trips in a Year.

New York, Dec. 2.—Benjamin Alexander, a 12-year-old Russian boy, who, within the past year, has made seven trips between Europe and America, is again in the detention room at Ellis Island. Each time he stowed away on a steamer and each time he was deported promptly on his arrival at New York. Every time he put off at Rotterdam on the return trip and there he waited for the next ship and promptly stowed aboard and hid himself away. This time the boy arrived on the steamer Acadia, on which he had made one previous trip. The Hebrew Charities society has taken an interest in the boy and is seeking two under who are supposed to live in New York and who the boy believes, will give him employment.

## HOUSE SERVANTS.

More Seeking Places in New York Than There Are Places For.

New York, Dec. 2.—There are more women and girls in New York seeking places as house servants than there are places for, according to Mrs. W. J. Wimmering, head of the bureau of social requirements. Every ship entering New York is bringing more of them, according to reports, and the employment agencies are overwhelmed with applications for places. Mrs. Wimmering states that there has been a decided decline in the number of servants employed by the wealthy in New York in the past month, which fact is partly responsible for the large number of idle servants. Both the French and German charity homes which care for immigrants are crowded to overflowing and the managers say it is impossible to find places for the girls who are arriving on every ship.

Tommy Puts Alleged Champion Away in the Tenth Round.

London, Dec. 2.—Tommy Burns of America knocked out Gunner Moir of England in the tenth round before the National Sporting club here tonight. Englishmen never had hopes of the ability of their representative to regain their lost honors in the boxing arena, and in a somewhat exciting contest the American champion had a comparatively easy task in disposing of Moir's pretensions and securing for himself the title of heavy-weight champion of the world.

After the round Burns' victory was certain, and in the tenth when the Gunner failed to rise to the call of time, and was literally cut to pieces, Burns left the ring with scarcely a mark. Moir over his right to participate in championship matches more to influence than to merit, and his defeat, therefore, was not a matter of great surprise. Burns proved himself superior in every detail. He displayed greater science and infinitely better generalship, and his blows were delivered with more power than those of Peter Jackson. It was an easy victory for the American, which, from the very outset appeared almost a foregone conclusion.

## BURNS HEAVY FAVORITE.

The contest aroused a greater amount of excitement and enthusiasm than any decided at the National Sporting club since Slavin's defeat at the hands of Peter Jackson. Burns entered the ring the favorite at odds of 2 to 1, which would have been still longer, but for the fact that the two titled backers of Moir covered the Burns money for a large amount in the chance of a big winning in addition to the stake money.

Except for the difference in weight and Moir's advantage of two inches in height, the men were evenly matched and in perfect form. In the first Burns' crouching attitude appeared to place him at a still greater disadvantage in height with Moir, who assumed a ready fighting position which arms extended widely and somewhat like a wrestler and showing no guard.

New York, Dec. 2.—Walter Camp, the great football expert, says that after two years of trial the new football rules have justified themselves. When the rules were first adopted critics said that the provision requiring the ball to be advanced to yards in three downs would result in many no-score games, but the result has been exactly the opposite. This rule also caused the abandonment of heavy massed rushes, which were used for two or three yards, but no more. The unlimited forward pass which can be tried now without serious penalty on first and second downs is a worthy feature of the new game, which students of football seem to think should be curtailed.

## A. A. U. DECIDES TO CLEAN HOUSE SOON.

New York, Dec. 2.—The registration committee of the Amateur Athletic union has decided to clean house.
