Henry Ward Beecher, he, Mr. Beecher, refused to do so, and a committee of his church members to inquire into the injury done him by Mr. Tilton by the aforesaid allusion, and implying that he, Beecher, had never been guilty of such offense of apology, and that Mr. Tilton had been a slanderer; that to make this inquiry bear credit, he, Mr. Beecher, previously connived with Mrs. E. R. Tilton to give false testimony in his, Beecher's, behalf; that Beecher's course towards Tilton and family has at least resulted in the open destruction of Mr. Tilton's household and home, and the desolation of his heart and life.

SPAIN.
The Defence of Cucaña.
MADRID, 21.—An official report of the loss of Cucaña has been received. The defence was brave and obstinate to the last. On the 12th inst. the Republic of Cucaña, Faubourg Carrieta, repelled three assaults made by Don Alfonso, with 8,000 men; the Carlists ultimately captured the Faubourg. The Republic was reduced to a strip of square of the town and refused to surrender; four more assaults were made upon the Carlists, who had the Carlists met with a repulse. During the morning of the 15th, after the firing had lasted 56 hours, the Carlists gained the square, and the Republicans began to retreat to the citadel, when they suddenly encountered a fresh force of 4,000 Carlists, who by some unexplained means had gained possession of the citadel. General Givoleas, the Republican commander, and all the officers and men then surrendered as prisoners of war. The Carlists sacked and burned many houses, murdered a number of the inhabitants, made heavy requisitions for provisions, demanded a contribution amounting to two years' taxes paid by the city, and destroyed the fortifications. The enemy reported a loss of 150 killed and 700 wounded.

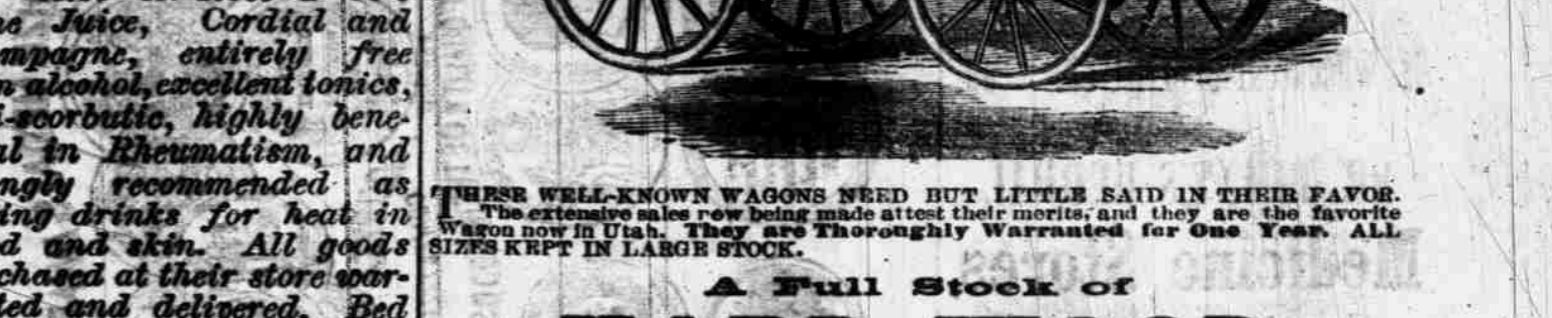
