NEWS OF THE ELECTIONS!

MISMANAGEMENT OF THE ARMY OF THE LOIRE!

Preparations to withstand a Siege at Lyons!

Opposition to the Candidacy of Aosta for the Spanish Throne!

NEW YORK.

The Prussian demands—Movements of the army of the Loire—Elections.

NEW YORK, 9.—The correspondent of the World, writing from Versailles on the 7th inst., says, no truce is agreed upon, because the government insisted on repossessing the city, which the Prussian military authorities refused, although Bismarck was willing to concede it. Prussia stated her demands with considerable distinctness, excepting in regard to money. Her conditions were the cession of Haute and Bas Rhine, the two departments containing the fortresses of Strasbourg, Belfort, and several lesser strongholds. As for money, she will not fail to reckon every crocheted Pruss has spent in the war and demand its repayment.

I had a lengthy conversation with M. Thiers. He informed me of the diplomatic journey he had performed through Europe. He informed me it was not true that England had taken the lead in the endeavor to obtain terms from France, while Russia stood aloof. The reverse is true. Thiers found Gladstone engrossed in the home office. He was indifferent as to the concerns of the world and was afraid to meddle with them. The Queen did not seem awake to the danger arising for England from the formation of an all powerful monarchy in the centre of Europe.

At St. Petersburg Thiers found friends. Who knows what Russia would have done had she been ready, but she was not armed. She could only give the weight of her influence and the action of her diplomacy. This was enough to rouse England and make her take the lead. Then the four powers agreed to address Prussia collectively, and Austria was glad to do that little for a power whose success would have delighted her. Italy, the least friendly of all the powers, hastily conceded her regret at the fall of the Bonaparte dynasty.

Returns from the State and city come in very slowly. Enough have been received however, to warrant the assertion that Hoffman's majority will reach 30,000 in the State, and it may run up to 35,000. Hoffman estimates that this will be his majority in the State, calculating that the ten thousand given for him in King's county will counterbalance all that he may lose in the rural districts. The Democratic gain over 1868 is steady throughout the State. They gain three Congressmen, electing J. W. Warren in the Troy district, and claiming Mavin's defeat in Saratoga. St. John, Republican, has carried Van Wyck's old district; and Ketchum, Republican, has been re-elected by an increased majority in the Columbia district. Hothkiss' district, which the Democrats hoped to carry on account of the Republican quarrel, has gone Republican. Elias H. Roberts, Republican, is elected in the Ulster district; while Duell, regular Republican candidate, has defeated McCarthy in the Oneida district. Sessions runs behind his ticket in Chataqua, though he is in no danger. William Williams, Democrat, is elected in the Erie district. This makes the Democrats gain three. The assembly looks close.

Roosevelt is elected in the 4th Congressional district over McMahon. The Republicans have elected sixteen and the Democrats fifteen Congressmen. The vote in the 7th district was, Ely 12,463, McAlpine 3,435, Willis 901. In the 6th Congressional district, Cox had 9,242, and Greeley 8,238. In the 5th district Brooks has 4,000 majority. In the 23rd Congressional district the Republican candidate is elected by over 300.

The city of Troy gives Hoffman 1,400 majority. The Democrats are said to concede the election of St. John, Republican, to Congress in the 11th district. In the 13th district, Williams, Democrat, is elected to Congress by 500 majority. Saratoga county gives 1,000 Republican majority. Carroll, Democrat, is elected to Congress in the 18th district. In the 4th district, Roosevelt, Tammany Democrat, is elected; in the 5th district, Roberts; in the 6th district, Cox; in the 7th district, Ely; in the 8th district, Brooks; and in the 9th district, Wood—all Tammany are elected.

In the 19th district, Prindle, Republican, is elected to Congress by 2,000 majority. The total vote in the city for Hoffman is 83,790, for Woodford, 33,679. New York, 8.—In the 14th (Albany) District, Perry, Democrat, is elected to Congress. The total Majority vote is: Hall, 70,339; Ledwith, 44,293. The 5th Congressional District gives Roberts 14,597; Briggs, 13,893; Gibbons, 129.

The majority vote stands, as far as known, Hall 65,631. Led with 41,271. The Tribune estimates Hoffman's majority in the State at 30,000. It practically gives up the assembly. Chenango county gives 1,400 Republican majority; Genesee county, 2,000 Democratic; Dutchess county, 1,280 Republican.

NEW YORK, 9.—The Tribune's special, headquarters of the army of the Loire, 6th, says, this army has increased rapidly and numbers 100,000 men. Artillery is abundant, but harness and saddles are deficient. The men are well equipped and fed. The French generals can't make it out why they have been permitted to concentrate so large a force unmolested. The French themselves, when changing front at Salbas, intended to attack but did not because the movement took six days instead of twenty-four hours. Their failure was due to the interference of the Tours government, which insisted on directing every detail, and had its own plan of battle; everything broke down from sheer ignorance and incompetency. Yet the generals are now blamed for delay.

KENTUCKY.

The Elections.

LOUISVILLE, 8.—Winchester, Democrat, candidate for Congress, is elected by 1,600 majority. The returns from twenty towns in the State show Republican gains, owing to the negro vote. The Democrats have carried seven Congressmen, from the first seven districts. In the 8th and 9th the result is doubtful.

The election in this city was quiet. Little interest was manifested and the vote polled was small. Winchester, Democrat, carries the city by 15,000, being 2,000 majority over Speed, Republican. Winchester's majority in the district will be nearly 4,000. Returns from different portions of the State indicate a great apathy on the part of the voters, many persons not being even aware there was an election to-day. The Democrats have certainly their candidates in all the districts but the 8th, the result in which is doubtful; but it is thought Adams, Democrat, is elected by a small majority. Speed, the Republican candidate, carries the 4th and 5th wards of this city, Winchester carrying the other eight. Lexington, Paducah and Bowling Green give Republican majorities, there being a large negro vote in these cities. Their vote was cast solidly for the Republican party.

KANSAS.

The Elections.

TOPEKA, 8.—The Republicans have carried this county by about 1,000 majority. The Republicans elect a State Senator and Representative. The proposition to subscribe a hundred and fifty thousand stock to the Chicago and Southwestern Railroad was carried by about 1,000 majority.

MARYLAND.

In the 4th District, John Ritchie is elected to Congress by 500 majority. The total vote of Baltimore is 39,045, an increase of 9,000 over 1868, just the amount of the registered voters. In the 2nd Congressional district, Archer's majority is 7,000. In the 4th District, Ritchie has 1,200 to 1,500 majority. The Democrats claim the 1st district by 3,000 to 4,000 majority and the 2nd District by 1,200. The Republicans regard the 1st and 5th districts undecided.

MASSACHUSETTS.

BOSTON, 8.—In two hundred and ninety-six towns Claflin has a majority of 6,555 over Adams and Phillips. The vote in the above towns stands: Claflin 72,455; Adams, 55,601; Phillips, 20,289. The towns yet to be heard from will increase Claflin's majority. We have reports of 229 representatives to the General Assembly, divided as follows: Labor, 151; Democrats, 35; Labor, 11; Prohibitionists, 2. The Senate has a Republican majority. The Republicans have carried the ten Congressional districts.

MISSOURI.

The Elections.

ST. LOUIS, 9.—The vote in this city is not counted yet. Seventeen precincts give Brown 1,143, and McClurg 1,848. Seven precincts in the 1st Congressional District give Wells, Democrat, 3,619; Johnson, Bolter, 1,647, and Smith, Regular, 485. The Democrats claim Wells reelected by 1,500 majority, and about the same majority for the entire county ticket.

ST. LOUIS, 8.—The judges in some of the precincts have stopped counting for the night, and others are making such slow progress that there is no hope of obtaining even an approximate vote of the city to-night. Eleven precincts give Brown 3,968; McClurg, 1,217. Three precincts of the 1st Congressional District give Wells, Democrat, 3,500; Johnson, Bolter, 6,880; Smith, Republican, 277.

The Brown men claim that the measure returns from the State indicate a larger majority for Brown than was anticipated. In this county it is from 8,000 to 10,000.

ILLINOIS.

The Elections.

CHICAGO, 9.—The returns from the State election, as far as received, indicate a success for the Republican State Ticket by a reduced majority from last election. The Democrats claim to gain two and perhaps three Congressmen. Ingersoll, Republican, is defeated in the 5th District by Stevens, Independent and Democrat, by a 1,000 to 1,500 majority. Robinson, Democrat, is probably elected in the 5th District; and the Democrats also claim the election of Cable in the 4th District over Hawley, by a small majority. The probabilities are, however, that Hawley is re-elected. The Legislature is probably Republican, but the returns are too meagre to tell certainly. In many Senatorial and Representative Districts, there were

three or more candidates in the field, and especially in the northern part of the State there were many split tickets. In this District, Farwell, for Congress, has about 5,000 majority. All the Republican candidates of both branches of the Legislature, and for State and County officers, are elected. The Republicans have also elected all the city officers, except three Aldermen.

MINNESOTA.

The Elections.

MINNEAPOLIS, 9.—The Republican majority in the State will be about 1,200. Both the Republican candidates to Congress are elected by 3,000 to 4,000 majority. ST. PAUL, 9.—Ramsey county, including this city, gives a Republican majority of 400. The Republicans have gained some in the State Legislature.

VIRGINIA.

The Elections.

RICHMOND, 8.—The Congressional election to-day resulted as follows: 1st district, Dr. W. N. Martin, colored; 2nd district, Jas. H. Platt, Republican; 3rd district, Charles H. Porter, Republican; 5th district, Col. R. S. W. Duke, Democrat; 8th district, Wm. Terry, Democrat; 7th district, E. M. Broxton, Democrat. The 4th district is not heard from.

TENNESSEE.

The Elections.

NASHVILLE, 8.—The election to-day passed off quietly. Brown, Democrat, for Governor, carried Nashville and Davidson county by a large majority. Prosser, Republican, for Congress, carried Nashville by a majority of 725, and is ahead in the city and county 694, with seven districts to hear from. The total vote, as far as heard from, gives Prosser 2,834; Golladay 2,190; Peyton 1,438. The returns from the other counties will make Golladay's election certain. Hamilton elects a Democratic member of the Legislature, but gives Stokes 200 majority for Congress. Brown is elected Governor, running ahead of the Congressional ticket. The 1st, 2nd and 3rd Congressional districts are doubtful; the remainder are Democratic.

MEMPHIS, 8.—The official vote of this city gives Brown, Democrat, for Governor, 3,650. Vaughan, Democrat, is elected to Congress from this district by probably 5,000 majority.

NEW JERSEY.

The Elections.

NEW JERSEY.—In New Jersey Hazelton's majority in the 1st district is 4,000. Halsey, Republican, is elected in the 5th district, giving the Republicans four or five members. The Republicans carry both branches of the Legislature.

LOUISIANA.

The Elections.

LOUISIANA.—Sypher, Republican, is elected to Congress for the 1st district.

MICHIGAN.

The Elections.

DETROIT, 8.—The Republican majority in Michigan is about 25,000. In the 1st district it is somewhat reduced, but Waldron is elected by a respectable majority. In the 5th district the Democrats claim to have reduced Conger's majority; in the 6th, Sutherland, Democrat, is certainly elected over Driggs, by from 300 to 400 majority.

WISCONSIN.

The Elections.

MILWAUKEE, 8.—Alexander Mitchell, Democrat, President of the Milwaukee and St. Paul railroad, is elected to Congress by a handsome majority. The Republican majority in the State is about 6,000. Mitchell, Democrat, is elected in the 1st Congressional district, by 5,500 majority. The rest of the Wisconsin Congressional delegation is unchanged.

FOREIGN NEWS.

GREAT BRITAIN.

The rule of the Provisional Government condemned as arbitrary—Heavy cannonading—London enveloped in a fog.

LONDON, 4.—The Tours government promises to issue a manifesto shortly, explaining the cause of the rupture of peace negotiations at Versailles.

The Gazette de France demands an immediate election to put an end to the arbitrary rule of the provisional government. The Monitor mentions five military executions on Saturday last, through "Red" influences at Lyons and Marseilles.

Advices from Lyons state that the Germans are advancing to occupy Conant and the line to Nevers. There are twenty thousand German troops in Dijon, with sixty pieces of field artillery. The citizens of the town have been forced to contribute half a million francs, as security for the behavior of the inhabitants. A barricade committee has been formed at Lyons. The authorities there have recently received fifty thousand Remington rifles. Vast quantities of stores and a large number of cattle have been collected in anticipation of a siege.

LONDON, 9, 1.30 p.m.—The city is enveloped in a fog. London is as dark as midnight. A dispatch from Arlon states that

heavy cannonading was heard in the direction of Thionville on Saturday and Sunday. It is supposed a battle took place.

The Prussians in front of Paris have trained hawks to capture carrier pigeons sent out of Paris with dispatches.

SPAIN.

MADRID, 9.—Twenty-nine editors of journals, issued in this city, have united in a manifesto opposing the candidacy of the Duke of Aosta for the Spanish throne.

FRANCE.

A Sharp Fight.

VERSAILLES, via London, 9.—On Monday, a detachment of the 9th Prussian infantry encountered a body of the garde mobile, at Bretenay, between Boulogne and Chaumont. The French lost seventy killed and wounded.
