MISSIONARY EXPERIENCE.

On Oct. 9th we received a visit from Elder Joseph S. Allen, who returned yesterday (Oct. 8th) from a mission to the Southern States. He is a resident of Richmond, Cache County, and left Utah for his field Oct. 10th, 1887. He labored in the State of Mississippi until last June. As a rule he got along well, although he had a hot time occasionally, hav-ing been assailed by mobs three times. The first occasion was on the 12th of May, 1888, in Lafayette County, and at other times subsequent to that time. Elder Allen thus tells the story of these episodes:

Elder Wood and myself were laboring in Lafayette together, and started for the postoffice about two miles distant. When we had proceeded half-a-mile or so we came upon a vacant house and sat down upon the porch to rest, having not the slightest suspicion of what was to follow. Shortly afterwards, greatly to our surprise, about a dozen men came around the house from both sides, carrying shotguns in their hands.

They drew their guns down upon us, and informed us that we must consider ourselves their prisoners. We asked them what we had done to call for this, but some few minutes elapsed before they gave us an

answer.

Presently one of the number spoke up, saying, "It is for that d—rotten doctrine you are teaching. You can consider yourselves under arrest now, and you must come with

With this the mob marched us to a large mill-pond, where a number of other men, upwards of thirty, were awaiting our arrival. Most of them had shotguns. They elected a committee who were deputed to go on one side, consult, and resolve what should be done with us in the way of punishment. The decision of the committee was that I and my companion should leave the locality before four o'clock the same afternoon. This was at nine o'clock in the morning, so we had the day before us.

I told them, however, that they had better call another vote on the matter, as I did not think we could gather up our books, etc., and leave by the hour named for our depar-ture.
