DAY AND LOU-CHAT LABOR.

The question as to whether it is better for municipalities to have work done by contracts with the laborer or by direct employment, and whether the tendency of letting public utilities to lowest bidder has lowered the wages, have attracted attention in the bulletin of the department of labor, recently issued.
